\$7,137.00 was disbursed during February 2022.

March 2022

Continued discussion with the City to complete design phase and environmental review.

\$9,148.90 was disbursed during March 2022.

St. Clair County/East St. Louis Community Development Block Grant Housing Rehabilitation provided funding for 2 projects during the month.

Housing Rehabilitation funds disbursed totaled to \$10,366.00 during January 2022 .

February 2022

The County continued processing potential candidate applications submitted as a result of the most current Housing Rehabilitation lottery drawing and continued inspections and appraisals for various housing rehabilitation projects. St. Clair County/East St. Louis Community Development Block Grant Housing Rehabilitation provided funding for 3 projects during the month..

Housing Rehabilitation funds disbursed totaled to \$22,248.00 during February 2022.

March 2022

The County continued processing potential candidate applications submitted as a result of the most current Housing Rehabilitation lottery drawing and continued inspections and appraisals for various housing rehabilitation projects. St. Clair County/East St. Louis Community Development Block Grant Housing Rehabilitation provided funding for 1 projects during the month.

Housing Rehabilitation funds disbursed totaled to \$23,241.00 during March 2022.
