REQUEST FOR RELEASE OF FUNDS

On or about December 1, 2025 the St. Clair County Intergovernmental Grants Department will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of CDBG-DR funds under Public laws making CDBG-DR appropriations; provisions of Title I of the Housing and Community Development Act of 1974 (42 U.S.C. 5301, et seq.); Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5121, et seq.), as amended, to undertake the following project:

Project / Location

Project Name: 5th St Storm Water Pump Station to Mitigate Property Flooding

Project Location: Near Stone Street and 5th Street Dupo, IL 62239

Project Description: The project will consist of constructing a storm water pump station next to a village storm collection basin on the west side of North 5th Street, install a new 24" diameter storm water pipe below North 5th Street that will discharge into a farm field, the installation of additional conveyance piping north of the collection basin to improve drainage aways from Stone Street and Lime Street. With the addition of a new storm water pump station and extensive work being completed, this project will include ground disturbance.

Approx. Federal Funding: CDBG-DR - \$ 1,570,800.00

Estimated Total Project Cost: \$ 1,580,000.00

FINDING OF NO SIGNIFICANT IMPACT

The St. Clair County Intergovernmental Grants Department has determined that the projects will have no significant impact affecting the quality of the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the St. Clair County Intergovernmental Grants Department. All comments received by November 30, 2025 will be considered by the St. Clair County Intergovernmental Grants Department prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The St. Clair County Intergovernmental Grants Department certifies to HUD that Mark A. Kern in his official capacity as Chairman, St. Clair County Board consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the St. Clair County to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the St. Clair County Intergovernmental Grants Department certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the St. Clair County Intergovernmental Grants Department; (b) the St. Clair County Intergovernmental Grants Department has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to HUD at 77 West Jackson Blvd, Chicago, IL 60604-3507.
