Dear Mr. Lopinot,

Section 20 ILCS 2505/2505-810 of the Illinois Compiled Statute, passed under Public Act 103-0008, created the Veterans Property Tax Relief Reimbursement Pilot Program. Under this program, taxing districts in qualifying counties may be eligible for a reimbursement of a portion of the property taxes paid due to a reduction in Equalized Assessed Value (EAV) attributable to the homestead exemptions under 35 ILCS 200/15-165 and 15-169 of the Property Tax Code.

Attached you will find a list of those qualifying taxing districts and the eligible reimbursement amount that is to be paid to each of them. You will be receiving a separate, lump-sum payment from the Illinois Comptroller's Office that will cover the aggregate amount due to the taxing districts. Reimbursement shall be distributed by the County to the taxing districts as outlined on the attached list.
