#### VOTER INTEGRITY HOTLINE

St. Clair County Clerk Thomas Holbrook has created, in cooperation with St. Clair County State's Attorney James Gomric, St. Clair County Sheriff Rick Watson, Illinois Attorney General's Office, and the United States Attorney's Office, a reporting system to assist the public in reporting violations of the voting process in St. Clair County. This is an integrated system established to report violations of the voting process in St. Clair County.

All emails received will be sent to the U.S. Attorney, the St. Clair County State's Attorney, St. Clair County Sheriff, and St. Clair County Clerk's Election Department automatically. All letters and complaints filed by phone at the Election Department will be documented, scanned and automatically distributed through the same voter integrity email system.




