Commissioner Polites reviewed the <u>Monthly Budget Analysis Report for February</u> 2015, and asked that it be placed on file, stating that the 2015 Budget is in line with the projected percentage of 16.7% expenditures.

Commissioner Polites reviewed the <u>Trial Balance Report for January 2015</u>, and asked that it be placed on file. The Secretary has a copy available for review in the Public Building Commission Office.

Under For Your Information, Director of Buildings, James Brede, explained that, on February 10, 2015, Advanced Elevator, the company that services the elevators for the Public Building Commission, informed him that the elevator pump for the freight elevator at the St.

Clair County Jail Kitchen is failing. Director Brede explained that, with Chairman Sauget outof-town and in light of the emergency, he contacted Commissioner Nations, as Vice-Chairman of
the Public Building Commission, to obtain permission to proceed with ordering a pump.
Director Brede stated that Commissioner Nations responded via e-mail and granted permission to
proceed with ordering the pump. Commissioner Nations moved to ratify the action at a cost notto-exceed \$27,188.00. Second by Commissioner Effinger. Roll call as follows:

Under Operations, Director Brede presented a request for contract approval for the Detention Center Generator to Calhoun Construction, who came in with the low bid of \$87,612.00. BRiC Engineering reviewed the proposal and felt confident that Calhoun could complete the job. Commissioner Nations inquired if Calhoun was the sole bidder. Director Brede informed that there were four bidders, with the next lowest bid at \$101,000.00. In response, Commissioner Nations confirmed with Director Brede that Calhoun was the lowest responsible bidder, to which Director Brede responded in the affirmative. Commissioner Nations moved approval to award Calhoun Construction the contract for the Juvenile Detention Center Generator Replacement at a cost of \$87,612.00. Second by Commissioner Polites. Commissioner Nations requested clarification as to what the Addendum covers. Director Brede indicated that it is for the Jail Lobby/Investigations Renovation. Commissioner Nations moved approval of an award to IMPACT Strategies in Amendment to the Master Standard Form Agreement to do necessary renovations to the St. Clair County Jail in an amount not-to-exceed \$405,450.00. Second by Commissioner Effinger. Roll call as follows:

For Airport Operations Business, Tim Cantwell, MidAmerica St. Louis Airport Director, provided numerous updates. In regard to the Allegiant flights, Director Cantwell explained that the Orlando route will not go in hiatus in August because of the maturing of the route; while a hiatus for the St. Petersburg route remains to be decided. Director Cantwell updated the Commission on the business side of the Ningbo warehouse as well as the warehouse building itself. Director Cantwell explained that Ningbo changed their chiller plans and will rebuild the 30,000 square foot chiller, to be completed by June, with Ningbo to be capable of hosting operations in June for the cargo side. Director Cantwell stated that, in regard to the passenger side, there are obstacles to the perception of going to Illinois as compared to St. Louis.

Director Cantwell requested Executive Session for purposes of Real Estate.

Commissioner Polites moved to enter into Executive Session for purposes of Real Estate.

Second by Commissioner Effinger and carried.
