- Kevin Hutchison updated the Group on NGA site in O'Fallon. Open dumping and an abandoned well was located on the site. Clean Sweep removed debris from the site, however large machinery remains and the well needs to be properly abandoned.

- Barb Hohlt updated the Group on Illini Environmental's plans to start a residential Household Hazardous Waste drop off program in Caseyville, IL.
