- Brandy of Mike Lowry's office at Trinity Services reported on November 19, 2015 that the residents are still doing clean up at Silver Creek Preserve two to three days a week as weather permits.
- > St. Clair County Parks Grant Commission:
  - The usual completion of projects, requests for extensions and payment of invoices for Cycles 20, 21 and 22 have been processed during the last month.
