#### Silver Creek Preserve:

Mr. Isbell reported on October 19, 2015 that all is quiet at Silver Creek Preserve except that sometime between Friday and Saturday, October 16<sup>th</sup>& 17<sup>th</sup>, someone took all the trash liners out of the trash cans and shook them out in the weeds.
