Environment Committee Report, September 22, 2015

From EDG meeting, September 15, 2015

- 62 Environmental contacts were made during the month of August
 - 2 Open Dump sites were closed
 - 6 Landfill Inspections were conducted
 - 1 Compost Site Inspection was conducted

- HB 2046 was passed to release public health funds.
 - Lorraine Haywood has been selected as a new member of the Board of Health. Dr. Vest is retiring and Dr. Jay Magner has been selected as a possible replacement.
 - The St. Clair County Health Department is sponsoring a campaign during October to urge people to Go Green and practice the 3R's – Reduce, Reuse & Recycle. Residents are asked to voluntarily fill out cards pledging to recycle their solid waste. The cards will be collected by the Health Department and used in a live drawing on Friday, November 13, 2015 at 11:00 AM. Prizes TBA.
 - Ozone season will end on September 19th.
 - St. Clair County has identified two positive human cases of West Nile Virus, one resulting in death. The SCCHD has collected enough statistical data for the State to stop collections and testing of mosquitoes. We will still collect birds until further notice. Staff presented WNV at Maryville University.
