### TRUSTEE COMMITTEE MEETING - APRIL 20, 2016

The meeting was called to order by Lonnie Mosley at 7:00 p.m.. Roll call was taken, showing a quorum present as follows.

### 1. MINUTES:

A motion was made and seconded to approve the minutes of the March 23, 2016 Trustee Committee Meeting. Motion carried.

## 2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. **Revolving Account Activity**: The Revolving Account Activity Report for March 2016 shows a Beginning Balance of \$12,549.98, Total Disbursements of \$22,992.00, Receipts of \$38,701.89, Allocated Pool Interest in the amount of \$4.63 with a Balance at Month End of \$28,264.50.
- b. **Payment Account Activity**: The Payment Account Activity Report for March 2016 shows a Beginning Balance of \$699,192.02 and a Balance at Month End of \$621,019.95.

#### c. Monthly Redemption Reports:

The Real Estate Monthly Redemption Report for March 2016 shows the Amount of Penalty as \$43,230.12; the Amount of Tax as \$130,112.39; Year to Date Totals of the Amount of Penalty as \$158,184.02 and the Year to Date Amount of Tax as \$458,361.01. The Total Collected Year to Date is \$616,545.03.

Any extension will require full County Board approval. Motion carried.

Motion carried.

## 4. **DEMOLITION PROGRAM**:

Mr. Mitchell reported that on April 19, 2016 he had the Washington Park demolition bid opening. There were three (3) bidders which were: Hanks at \$125,100.00, Hayes at \$88,725.00 and Shafer at \$92,992.00. Hayes was the lowest qualified bidder at \$88,725.00. Mr. Mitchell stated he has not contacted Hayes because he wanted to meet with the Committee first because on the last project it took Hayes so long to finish. Mr. Hubbard stated that he thought the Committee should give Mr. Mitchell authority to negotiate with Hayes stating that we will give them one more chance if they meet the parameters and if not met we will take them off the bid list. A motion was made by Mr. Mosley, Jr., seconded by Mr. Hubbard, to accept the bid of Hayes in the amount of \$88,725.00 pending Mr. Mitchell's negotiations regarding parameters to be met by Hayes. Motion carried. Mr. Mitchell stated he would let the Committee know when they are going to start.

Mr. Strohmeyer advised he had a call from a family that lives behind a lot owned by the Trustee with a tree on the back edge of the lot. The address is 408 Elm and the family lives on the opposite street that abuts up to the back of the lot. They have

children and there are limbs falling in the yard. The gentleman was very nice but wanted to know if anything could be done about the tree. The lot is in the auction and this is the second time it has been offered. Mr. Strohmeyer advised the gentleman that nothing would be done until after the auction but that he would bring it up at the Trustee meeting. Discussion ensued and it was recommended that we wait and see if the property sells at the auction. Mr. Mitchell stated he would look at the tree and report back.

## 5. OTHER BUSINESS:

Mr. Mosley, Jr. recommended a tour of the Washington Park demolition projects. Mr. Hubbard and Mr. Strohmeyer stated they agreed with that recommendation. Discussion ensued.

# 6. **ADJOURNMENT**:

A motion was made and seconded to adjourn at 8:13 p.m.. Motion carried.
