FRANK BERGMAN READ ALL THE CORRESPONDENCE FOR THE MONTH. IT WAS MOVED BY C. DAVID TIEDEMANN AND SECONDED BY JOAN MCINTOSH TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND REPORTS. MOTION CARRIED.

HERBERT SIMMONS REQUESTED THE EMA REPORT OF ACTIVITES FOR JULY/AUGUST 2016 AND LETTER FROM THE ILLINOIS EMERGENCY MANAGEMENT AGENCY DATED AUGUST 16, 2016 BE PLACED ON FILE.

JERRY DINGES NOTED THAT MARISSA IS MISSPELLED ON THE EMA REPORT.

ROY MOSLEY, JR. STATED DULY NOTED.

IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY JERRY DINGES TO ACCEPT AND PLACE THE EMA REPORT ON FILE. MOTION CARRIED.

TOM KNAPP REPORTED THAT THE JAIL POPULATION AS OF 2:00PM THIS AFTERNOON WAS 425 THE RATE OF CAPACITY IS 418 AT LITTLE HIGH FROM LAST MONTH.

ANGELA GROSSMAN-ROEWE ASKED ANY REASON.

TOM KNAPP STATED WE LOOKED AT WHERE WE WERE THIS TIME LAST YEAR WITH FELONS AND WE'VE ADMITTED 90 MORE FELONS THIS YEAR THAN LAST YEAR. SO I'M SURE THAT HAS A LOT TO DO WITH IT. THEY DON'T TURN OVER AS FAST.

TOM KNAPP ALSO REPORTED JAIL ACTIVITY FOR JULY 2016 WE ADMITTED 560 INMATES AVERAGE LENGTH OF STAY IS 5 DAYS AND OF THAT 560, 128 WERE FEMALES, 432 MALES AND OF THE 560 MISDEMEANORS 225 FELONS, 183 ANCILLARY CHARGES.

ON THE PATROL SIDE 233 TRAFIC STOPS ISSUED 117 CIATATIONS MADE 15 FELONY ARRESTS AND 30 MISDEMEANOR ARRESTS 55 WARRANT ARRESTS 108 COURTHOUSE CHECKS 519 PARKING PARTOLS. ACTIVITIES INCLUDED 65 ENVIORNMENTAL OFFICER CONTACTS 18 BY DEPARTMENT OTHER WISE 80 ENVIORNMENTAL CONTACT FOR JULY.

ANGELA GROSSMANN-ROEWE ASKED IF ANY TICKETS WERE ISSUED.

TOM KNAPP STATED NO BUT ORDINARILY THEY ARE LISTED.

DIXIE SEIBERT ASKED TOM KNAPP IF WE HAD A LOT MORE JUVENILES THAN IT USE TO BE.

TOM KNAPP STATED HIS DEPARTMENT DOESN'T HANDLE JUVENILES THAT'S THE DETENTION CENTER.

FRANK BERGMAN STATED HE HAD THE DETENTION CENTERS REPORT AND GAVE A COPY OF THE POPULATION REPORT TO HER.

DIXIE SEIBERT STATED SHE THOUGHT WE HAD MORE JUVENILES A COUPLE OF YEARS AGO.

IT WAS MOVED BY JERRY DINGES AND SECONDED BY C. DAAVID TIEDEMANN TO ACCEPT ALL REPORTS AND PLACE ON FILE. MOTION CARRIED.

FRANK BERGMAN REPORTED TO THE COMMITTEE THAT HE REVIEWED THE ACCIDENT REPORTS WITH NO CHANGES. IT WAS MOVED BY JOAN MCINTOSH AND SECONDED BY ROY MOSLEY, JR. TO ACCEPT ALL REPORTS. MOTION CARRIED.

THERE BEING NO FURTHER BUSINESS, IT WAS MOVED BY C. DAVID TIEDEMENN AND SECONDED BY ROY MOSLEY, JR. TO ADJOURN. MOTION CARRIED.
