HERBERT SIMMONS READ THE EMA REPORT FOR THE MONTHS OF NOVEMBER/DECEMBER 2016 AND REQUESTED THE EMA REPORT OF ACTIVITIES TO BE PLACED ON FILE. IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY DIXIE SEIBERT TO ACCEPT AND PLACE ALL CORRESPONDENCE AND EMA REPORT ON FILE. MOTION CARRIED.

TOM KNAPP REPORTED THAT THE JAIL POPULATION AS OF 2:00PM THIS AFTERNOON WAS 370 WITH THE RATE OF CAPACITY IS 418. FOR THE MONTH OF NOVEMBER WE ADMITTED 560 INMATES WITH AN AVERAGE STAY OF 4 DAYS AND OF THOSE 128 FEMALES 432 MALES 205 MISDEMEANORS 169 FELONIES. WE HAVE A NEW ENVIRONMENTAL GUY AND WE ARE UP IN ACTIVITY HE MADE 122 ENVIRONMENTAL CONTACTS ISSUED 8 ENVIRONMENTAL CITATIONS

AND THE REST OF THE DEPARTMENT ISSUED MADE 12 ENVIRONMENTAL CONTACTS ISSUED I ENVIRONMENTAL CITATION. TOM KNAPP ALSO STATED THE PATROL DIVISION AS A WHOLE FOR NOVEMBER MADE 208 TRAFFIC STOPS 135 CITATIONS 12 FELONY ARREST 29 MISDEMEANORS ARREST AND 42 WARRANT ARREST. THERE WHERE 205 COURTHOUSE CHECKS 544 PARK PATROLS AND OVER ALL 6066 CONTACTS. IT WAS MOVED BY ROY MOSELY, JR AND SECONDED BY DIXIE SEIBERT TO ACCEPT HIS REPORTS AND PLACE IT ON FILE. MOTION CARRIED.
