HERBERT SIMMONS REQUESTED THE EMA REPORT OF ACTIVITIES FOR JUNE/JULY 2016 BE PLACED ON FILE. IT WAS MOVED BY C. DAVID TIEDEMANN AND SECONDED BY JERRY DINGES TO ACCEPT AND PLACE THE EMA REPORT ON FILE. MOTION CARRIED.

MAJ. KNAPP REPORTED THAT THE JAIL POPULATION AS OF 3:30PM WAS 392 THE RATE OF CAPACITY IS 418. FOR THE MONTH OF JUNE THE AVERAGE POPULATION WAS 379 AND WE TOOK IN 608 PEOPLE AND RELEASED 627 OF THOSE 154 FEMALES AND 450 MALES.

MAJ. KNAPP ALSO REPORTED THERE WAS 35 ENVIRONMENTAL CONTACTS MADE OF THOSE 25 WHERE ENVIRONMENTAL CONTACTS AND 1 ENVIRONMENTAL RELATED CITATION ISSUED. THE DEPARTMENT MADE 9 ENVIRONMENTAL CONTACTS AND 1 ENVIRONMENTAL RELATED CITATION. IT SHOULD BE NOTED THE DECREASE IN NUMBERS REFLECTS DEPUTY YORK VACATION THE FIRST TWO AND HALF WEEKS OF JUNE.

MAJ. KNAPP ALSO REPORTED WE CONDUCTED 109 COURT HOUSE CHECKS AND 462 PARK PATROLS. IT WAS MOVED BY JERRY DINGES AND SECONDED BY ROY MOSLEY, JR. TO ACCEPT ALL REPORTS AND PLACE ON FILE. MOTION CARRIED.
