Kern, at 7:30 p.m., Monday, June 27, 2016, and pursuant to House Bill 476, the provisions have been complied with. Notices have been posted and supplied to interested Media as so stated in the House Bill. The meeting being held in the County Board Meeting Room B-564, 10 Public Square, Belleville, Illinois.

5 PUBLIC PARTICIPATION.

Mr. Christopher Heatherley, Belleville, Illinois. Mr. Heatherley addressed the County Board regarding keeping the parking garage open on County Board nights for people who cannot walk very far and are attending the meetings.

Brother Bob spoke regarding the Jones Park Summer Camp. Brother Bob stated he was there on Friday with Mr. Bob Romanik and was back today and the water is still not on. Brother Bob stated the \$10,000 that is being proposed tonight is not enough for the program and Mr. Bob Romanik has offered to donate \$10,000 and they do need the financial support. Chairman Kern responded advising that the \$10,000 request from the East St. Louis Park District to be used to open the Splash Park is on the Agenda tonight and hopefully will make a difference.

Unidentified individual inquired if Mr. Bob Romanik offered \$10,000 to get this park going out of his money, not taxpayer money, why was the money not taken instead of the request that is on the Agenda. The individual stated that this was about the children and if they had taken the \$10,000 it could have been open this morning. Chairman Kern responded advising that the East St. Louis Park District operates Jones Park and the St. Clair County Doard tonight has on its Agenda a request from the East St. Louis Park District to give them \$10,000 to open the Splash Park. Chairman Kern stated that the questions the individual was asking tenight should be asked of the East St. Louis Park District. We are not the East St. Louis Park District, we are the St. Clair County Board.

Unidentified individual spoke regarding the Jones Park Splash Pad request asking if there is more funding available that they do not know about and should be requesting. Chairman Kern responded advising that there is a tax levy collected by the City of East St. Louis on tax bills that pays for the Park District. There is also a sales tax that has certain rounds of grants and tonight we will be voting to pay \$10,000 to open the Splash Park and \$25,000 towards having Cahekia Mounds becoming a federal park. East St. Louis Park District applies for grants almost every cycle, but the general budget for the East St. Louis Park District is paid for by the citizens of East St. Louis and operates both Jones Park and Lincoln Park and all other parks. This Board also worked with the East St. Louis Park District to open a new pool at Lincoln Park. That request was approved by Governor Quinn but was cut by the Governor in office now. This Board worked towards a new pool and it was stopped and we hope to bring this about again. The request from the East St. Louis Park District was received on Monday.

Mr. Brad Van Hoose, Belleville, Illinois. Mr. Van Hoose stated he thought it was very generous of this Board to extend the funds to open the Jones Park Splash Park when it is ultimately not the County's responsibility. The Parks Grant Commission is a tax levied across three counties here in Southwestern Illinois. Mr. Van Hoose said he applauded this Board for stepping up and helping out.

Mr. Nick Holden, who is not a resident of St. Clair County. Mr. Holden stated that he was in support of the Splash Park being opened. Mr. Holden recommended if we are short of money that the Board Members should all take a ten (10%) percent pay cut.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statement was:

The disclosure of uncollected assessment receivables in Note 4 to the financial statement. All Circuit Clerk receipts are recognized when received, the receivable and any related provision for uncollectable receivables have not been recorded in the financial statement.

The financial statement disclosures are neutral, consistent, and clear.

We are pleased to provide an engagement letter for our services as Special Counsel to the County for annual continuing disclosure compilation and filing (the "Project"). For convenience and clarity, we may refer to the County in its corporate capacity and to you, the County officers (including the governing body of the County) and employees and general and other special counsel to the County, collectively as "you" (or the possessive "your"). The purpose of our engagement, briefly stated, is to assist the County with its annual continuing disclosure compliance obligations contained in its outstanding continuing disclosure undertakings as made under Rule 15c2-12 of the Securities Exchange Act of 1934 (each, a "CDU" and collectively, the "CDUs"). You are retaining us for this limited purpose as further described below. purpose as further described below.

A. DESCRIPTION OF SERVICES

As Special Counsel to the County for the Project, we will work with you to research and compile necessary materials to be timely filed with the Electronic Municipal Market Access system created by the Municipal Securities Rulemaking Board (and commonly known as "EMMA"), all in accordance with the the Municipal Securities Rulemaking Board (and commonly known as "EMMA"), all in accessisting CDUs of the County. We intend to undertake each of the following as necessary:

Accordingly, in light of all such relationships and consultations, we are requesting the County's consent to any conflict of interest that may exist or arise in our representation of the County in connection with our limited engagements for the County relating to the Project.

E. FEES

- 1. That HeartLands Conservancy be designated and supported as the entity to peruse this designation in the amount not to exceed \$25,000 on July 1, 2016; and authorized to request an additional \$30,000 on January 1, 2017, to complete tasks associated with this designation.
- 2. That this agreement includes no additional benefits of any kind, and is specifically limited to the remuneration mentioned above.
- 3. That the type of work assignments presently considered involve the continuation of feasibility planning efforts to attain National Park status, beginning with the pursuit of Monument status and culminating in a National Historical Park designation through Congressional authorization, as follows:

2016 Deliverables - Project Initiation, Data Collection & Analysis

- ullet Reconvene Steering and Technical Advisory Committee;
- Continue to pursue NPS designation to establish Cahokia Mounds and connected sites as a National Monument;
- Identify the Mounds and surrounding property by ownership and boundaries, including identifying partners, parcels and willing sellers;
- Legal work on deeds including developing memoranda of understanding for acquisitions
- · Community education and outreach;
- Update databases, mapping, and surveying parcels;
- Provide partnership outreach, education, and exhibits.

2017 Deliverables - Plan Finalization and Implementation

- Pursue expansion of the NPS designation to establish Cahokia Mounds as a National Historical Park through congressional legislation;
- Continued community outreach and education;
- Develop legislative document and agreements and supporting documentation;
- Expand the Mounds Heritage Trail east and south between thematically-connected satellite Mounds throughout St. Clair County;
- Identify related parcels, connectivity, links, and trail connections;
- Identifying and recruiting prospective partners for collaborative efforts such as funding potential site acquisitions, voluntary protection of remaining mound sites, identifying additional open space, funding, expansion, technical leadership, programming opportunities, and memoranda of agreements for operations and education;
- A parcel list of recommended tracts for inclusion in the national designation;
- Develop MOU/MOAs to develop a diverse partnership, whose purpose shall be to provide technical leadership, to identify projects, and to leverage financial resources and focus public and private investment in a manner which best advances the initiative;
- List of Potential Partners in recreation, educational, cultural institutions to develop interpretative, service teaming and programming opportunities;
- Develop priority linkages to other efforts to preserve and promote the Mississippian Culture along the Mississippi River and the Mississippi Watershed;
- Study on preferred sites (parcels) for opportunities for voluntary protection of remaining mound sites and/or future selected open space for interpretation of the Mounds; including lands in both public and private ownership;
- Final Report on National Park Designation.

This Agreement shall take effect upon its approval by the St. Clair County Board and the CEO of HeartLands Conservancy and immediately upon the signature of the parties hereto.

The East St. Louis Park District is seeking funds to operate the Kenneth Hall Splash Park located in Jones Park. This is the only aquatic facility the Park District can open this year. We obtained our State License early in the year in anticipation of possibly getting the required funds to operate.

However, Mr. Chairman, the RFP which the State of Illinois normally issues for summer programming again was not released due to the budget impasse. I contacted United Way to inquire on summer funds again this year; however, last year was a "one-time" grant awarded due to the Ferguson unrest. This year the RFP is for afterschool programming beginning September 1, 2016 through August 31, 2017. I sought funding through the application of other grants but did not receive them. The fund denials created a dilemma for the Park District to operate our normal summer program for our youth.

Americorp is interviewing today to send us young camp counselors and water park operators who will be unpaid but awarded a scholarship after completing 300 hours of volunteer time. This will give us the manpower that we need to open up. However, there are supplies which have to be purchased for the splash park to open and remain open for the summer, such as; chlorine and muriatic acid, water testing supplies, and heavy duty brass whistles with lanyards.

Funding assistance in the amount of \$10,000.00 from the County would allow us to get the Splash Park operating for the entire summer and would be greatly appreciated by the Park District and our entire community. I am attaching a picture of the children in the Splash Park from last summer, 2015.

CERTIFICATE OF COMPLIANCE

WHEREAS, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workmen employed in any public works by the State, County, City or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, (Illinois Compiled Statutes [820 ILCS 130/1] et seq.), as amended and

WHEREAS, the aforesaid Act requires that the County of St. Clair investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workmen in the locality of St. Clair County employed in performing construction of public works, for said County.

NOW, THEREFORE, BE IT RESOLVED, by the County Board of St. Clair County, State of Illinois:

SECTION 1: To the extent and as required by "An ACT regulating wages of laborers, mechanics and other workmen employed in any public works by State, County, City or any public body or any political subdivision or by any one under contract for public works", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in construction of public works coming under the jurisdiction of the County of St. Clair is hereby ascertained to be the same as the prevailing rate of wages for construction work in the St. Clair County area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the County of St. Clair. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the County of St. Clair to the extent required by the aforesaid Act.

SECTION 3: The County Clerk shall publicly post or keep available for inspection by any interested party in the main office of this County, this determination or any revisions of such prevailing rate of wages. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The County Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workmen whose wages will be affected by such rates.

SECTION 5: The County Clerk shall promptly file a certified copy of this Resolution with the Illinois Department of Labor.

SECTION 6: The County Clerk shall cause to be published in a newspaper of general circulation within the area a copy of this Resolution, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
