WHEREAS, the Zoning Board of Appeals, after considering the evidence and testimony presented at the previous hearings, the testimony and evidence presented on September 12, 2016 and October 3, 2016, after considering all relevant sections of the St. Clair County Zoning Code, and after further consideration of the matter, granted the applicant's a Special Use Permit to allow a Day Care Center in Single-Family Residence Zone District based upon the following findings and subject to the following stipulations: (1) That the prior use of the property and structure as a grade school, lends itself to being effectively utilized as a Daycare, and the property and structure is large enough that its shared use with the Applicant's church would not have any appreciable impact on the surrounding neighborhood, and thus, the proposed design, location, development and operation of the Special Use will adequately protect the public's health, safety, and welfare and the physical environment of the surrounding neighborhood. (2) This Special Use is consistent with the County's Comprehensive Plan. The County's Comprehensive Plan provides for government use; however, the property is not longer being used as a school and is no longer owned by the school district or any other governmental entity. Thus, as the use of the property for a Daycare may be allowed as a Special Use in the underlying Zoning District, SR-2, such a use would be in line with the County's Comprehensive Plan, as well as, similar to its prior use as a public grade school. (3) The Special Use Permit would not have an adverse effect on the value of the neighboring property, as past experiences of this Board have demonstrated that empty or abandoned properties or structures have a detrimental or negative effect on the value of neighboring property versus properties and structures that are being occupied and utilized. Further, following stipulations: (1) That the prior use of the property and structure as a grade school, lends neighboring property versus properties and structures that are being occupied and utilized. there was no credible testimony that the granting of this special use would have an adverse effect on the value of neighboring property. Moreover, the restoring of this property to a beneficial use would positively impact the County's overall tax base. (4) There will be very little to no impact on traffic circulation on nearby streets, as the use of this property as a Daycare, even in conjunction with a church, would have less of an impact than its previous use as a public grade school. There currently exists public access to this property, and the public streets in the vicinity are more than adequate to handle this use. (5) The property and structure are currently attached to the adequate public utilities to service the Daycare and its shared use as a church. (6) There are no nearby

facilities such as schools or hospitals that would need special consideration given the type of use applied for. (7) Given the property and the current structure in question, the old Belle-Valley North School, the use of this property as a Daycare would be compatible to adjacent uses in the general vicinity, and in harmony with its prior use. (8) Further, as a stipulations and conditions to this Special Use Permit. (a) This Special Use is issued to Abundant Life Ministries, Inc. only, and is nontransferable. It does not run with the land. (b) The applicant will adhere to those supplementary use provisions of Section 40-5-19. (c) The Applicant will adhere to all County and State rules and regulations, including any and all applicable Health Department, State Fire Marshall, and Department of Children and Family Service's rules and regulations. (d) The Applicant will adhere to the site plan as submitted by it, and it's hours of operation as testified to, Monday through Friday, 6 a.m. to 7 p.m. m.q

#### # 9-a-3 ORDINANCE - PROHIBITING THE USE OF GROUNDWATER AS A POTABLE WATER SUPPLY BY THE INSTALLATION OR USE OF POTABLE WATER SUPPLY WELLS OR BY ANY OTHER METHOD.

#### ORDINANCE NO.

AN ORDINANCE PROHIBITING THE USE OF GROUNDWATER AS A POTABLE WATER SUPPLY BY THE INSTALLATION OR USE OF POTABLE WATER SUPPLY WELLS OR BY ANY OTHER METHOD.

WHEREAS, certain properties in St. Clair County, Illinois, have been used over a period of time for commercial/industrial purposes; and

WHEREAS, because of said use, concentrations of certain chemical constituents in the groundwater beneath the County may exceed Class 1 groundwater quality standards for potable resource groundwater as set forth in 35 Illinois Administrative Code 620 or Tier 1 remediation objectives as set forth in 35 Illinois Administrative Code 742: and

WHEREAS, the County desires to limit potential threats to human health from groundwater contamination while facilitating the redevelopment and productive use of properties that are the source of said chemical constituents;

NOW, THEREFORE, BE IT ORDAINED, by the Board of St. Clair County, Illinois:

SECTION 1. USE OF GROUNDWATER AS A POTABLE WATER SUPPLY PROHIBITED. The use or attempt to use of groundwater as a potable water supply within the limited area depicted on Exhibit A, attached hereto and incorporated herein, by the installation or drilling of wells or by any other method, including at points of withdrawal by St. Clair County, is hereby prohibited.

SECTION 2. PENALTIES. Any person violat fine of up to \$1,000.00 for each violation. Any person violating the provisions of this Ordinance shall be subject to a

SECTION 3. DEFINITIONS. "Person" is any individual, partnership, co-partnership, firm, company, limited liability company, corporation, association, joint stock company, trust, estate, political subdivision, or any other legal entity, or their legal representatives, agents, or assigns. "Potable Water" is any water used for human or domestic consumption, including, but not limited to, water used for drinking, bathing, swimming, washing dishes, or preparing foods.

REPEALER. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance.

SEVERABILITY. If any provision of this Ordinance or its application to any person or under any circumstances is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.

EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

The property/casualty premium is down \$20,553 from \$973,470 to \$952,917. Physical damage on vehicles is down \$510,723 and total vehicles are down 7 from last year. Building values are up \$1,461,053 from \$146,105,297 to \$147,566,350. Law enforcement liability premiums are trending upwards as across the nation so I am happy we are receiving a decrease for St. Clair County. Also, the Sheriff's Department is making great use of the LLRMI (Legal & Liability Risk Management Institute/Jim Alsup) training. Through October they have taken 584 courses this year! That earns a discount on this policy which helps a great deal.

The workers compensation premium increased a total of \$86,349 from \$354,477 to \$440,826. The experience modifier increased 66% from 1.20 to 1.86. Kyle Shell, in loss control, is making some traction but we could use more help in convincing the elected officials and other offices in the importance of Kyle. We would also like to see early return to work implemented as well. In the last three years the County has paid \$738,251.47 in lost time.

The excess flood and earthquake policy is up \$8,394 from \$270,203 to \$278,597. This is because the building values are up \$1,461,053.

The pollution liability policy increased \$0. Premium is \$8,162. This policy has already renewed on 10/01/2016 and is paid in full.

Overall total premium is up \$74,190 from \$1,598,150 to \$1,672,340 (+4.6% overall).

## # 9-b-6 CONTRACT WITH WEXFORD FOR MEDICAL SERVICES AT THE ST. CLAIR COUNTY JAIL.

COUNTY OF ST. CLAIR, ILLINOIS

INMATE HEALTH CARE PROGRAM

CONTRACT EXTENSION AMENDMENT

THIS AGREEMENT by and between the County of St. Clair (hereafter referred to as "County") and Wexford Health Sources, Inc. (hereafter referred to as "Wexford"), is entered into as of the 1st day of January, 2017.

## WITNESSETH:

WHEREAS, County is charged by law with responsibility for administering, managing, and supervising the healthcare delivery system of the St. Clair County Jail ("Jail"); and

WHEREAS, the objective of the County is to provide for the delivery of quality health care to inmates in accordance with applicable law; and

WHEREAS, Wexford is in the business of providing correctional healthcare services and desires to provide such services for the County under the terms and conditions hereof;

THEREFORE, with the intent to be legally bound, and in consideration of the covenants and promises hereinafter made, the parties hereto agree as follows:

## IT IS MUTUALLY AGREED BETWEEN THE PARTIES:

To renew the following terms of the contract to reflect the planned expansion of the St. Clair County Jail, the commodity/equipment and service needs of the increased inmate population, and to initiate a five-year extension of the current contract term to commence January 1, 2017 through December 31, 2021.

## ARTICLE II: PERSONNEL

 $\underline{\text{Staffing.}}$  For the purposes of rendering healthcare services to inmates hereunder, Wexford will provide medical, dental, technical and support personnel as set forth herein. The healthcare staff will be at levels consistent with those described below, as currently provided:

2.9 <u>Facility Expansion/Staffing.</u> In the event that the Jail Facility is expanded, Wexford Health and the County will negotiate a suitable increase in staffing requirements that meet the operating needs of the facility. Staffing plan should reflect current clinical medical staff to inmate ratios. Base Compensation shall be adjusted to reflect any negotiated staffing increases.

#### ARTICLE VII: TERM AND TERMINATION OF AGREEMENT

#### ARTICLE VIII: COMPENSATION

- Base Compensation. County will make advance payments of 1/12 of the total estimated annual contract amount to Wexford on the first of each month. The estimated total contract for the first extension year of the contract is \$1,268,968, a 0% increase from the previous contract year. In the event this Agreement should terminate on a date other than the end of a calendar month, compensation to Wexford will be prorated accordingly for the shortened month.

  Increases in Inmate Population. Should the monthly average inmate population be greater than 400 tes, the County shall pay Wexford the per diem rate of \$1.60 per inmate per day. Population
- inmates, the County shall pay Wexford the per diem rate of \$1.60 per inmate per day. Population adjustments for inmate population that exceed an ADP of 400 up to 424 shall be waived for the duration of the contract. Should the monthly ADP reach 425 or higher Wexford shall be reimbursed at the established population adjustment rate for the population exceeding 400.

The per diem adjustment is intended to cover the variable cost increases as a result of minor fluctuation of the facilities ADP. However, the per diem adjustments are not intended to provide for a significant increase in the cost of pharmaceuticals or staffing as a result of a rapid unforeseen or uncontrolled population increase. As such, if the monthly average ADP reaches 600 inmates, or as necessitated by increased service demands, Wexford and the County will negotiate a suitable increase for staffing compensation.

- Annual Adjustment. Annual adjustments in price and per diem for subsequent years will be the previous year's contract price increased by a fixed rate of 3.0% for 2018, 0% for 2019, 3.0% for 2020, 0% for 2021. Extension years beyond 2021 shall be negotiated between Wexford and the County.
- Facility Expansion/Compensation. In the event that the St. Clair County Jail Facility is expanded, Wexford Health and the County will negotiate an increase in the base compensation based on the new increased population level according to the terms established in Section 8.3, Increases in Inmate Population. The minimum population level shall be changed to the agreed upon expansion population and the population variance waiver adjusted to reflect the new population level.

## ARTICLE VI: OFFICE SPACE AND EQUIPMENT

6.4 <u>Facility Expansion/Supplies and Equipment</u>. In the event that the St. Clair County Jail Facility is expanded, Wexford Health and the County will negotiate necessary supply and equipment needs to meet the increased population. Wexford Health shall prepare recommended equipment and supply lists for approval by the County. Upon approval, Wexford Health shall work with the County on the purchase of all needed expansion start-up equipment and supplies. All expansion start-up equipment and supplies purchased by Wexford Health shall be reimbursed by the County.
