IT WAS MOVED BY JERRY DINGES AND SECONDED BY ROY MOSLEY, JR. TO APPROVE THE MINUTES. MOTION CARRIED.

FRANK BERGMAN READ ALL THE CORRESPONDENCE FOR THE MONTH. IT WAS MOVED BY C. DAVID TIEDEMANN. AND SECONDED BY DIXIE SEIBERT TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND REPORTS. MOTION CARRIED.

HERBERT SIMMONS REQUESTED THE EMA REPORT OF ACTIVITES FOR OCTOBER/NOVEMBER 2016 BE PLACED ON FILE.

ROY MOSLEY, JR. STATED YOU MET WITH THE CITY MANAGER OF EAST ST. LOUIS IN REGARDS TO THE CONSOLIDATION.

HERBERT SIMMONS STATED YES IT WENT WELL WE HAD A CONVERSATION TODAY TO GET THEIR GENERATOR INSTALLED TOMORROW NIGHT BUT THEY CALLED AND CANCELLED. THEY ARE GOING TO RESCHEDULE. THE REASON IS THEY ARE TRYING TO GET THE NUMBERS FOR THE CONSOLIDATION CONSIDERATION.

ROY MOSLEY, JR. ASKED IS THE GENERATOR AN ISSUE AND WHAT DOES THAT MEAN.

HERBERT SIMMONS STATED THEY HAVE IT IN PLACE THEY'RE TRYING TO COORDINATE A HOOKUP WITH AMEREN UE. WE ARE GOING TO TAKE OUR MOBILE COMMAND POST THERE SO THEIR 911 CALLS WILL NOT BE INTERUPTED.

IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY JERRY DINGES TO ACCEPT AND PLACE ALL CORRESPONDENCE AND EMA REPORT ON FILE. MOTION CARRIED.

TOM KNAPP REPORTED THAT THE JAIL POPULATION AS OF 3:00PM THIS AFTERNOON WAS 376 WITH THE RATE OF CAPACITY IS 418. HE ALSO STATED THAT FOR THE MONTH OF OCTOBER STAYING WITH THE JAIL REPORT WE ADMITTED 587 INMATES 150 WERE FEMALES, 437 WERE MALES. 253 WERE BOOKED FOR MISDEMEANORS, 168 FELONYS. ALSO IN THE MONTH OCTOBER 191 TRAFFIC STOPS, ISSUED 83 CITATIONS 14 FELONY ARREST 18 MISDEMEANORS AND 37 WARRANT ARRESTS. COURT HOUSE CHECKS 151, PARK CHECKS 539 SO WE ARE STAYING ON THE PARKS. THE ENVIRONMENTAL OFFICER WAS CHANGED FOR THE MONTH OF OCTOBER SO WE EXPECT HIS ACIVITY TO IMPROVE. HE ISSUED 77 ENVIRONMENTAL CONTACTS, ISSUED 4 ENVIRONMENTAL RELATED CITATIONS. IN THE DEPARMENT OTHER OFFICERS MADE 12 ENVIRONMENTAL CITATIONS AND 1 ENVIRONMETAL CITATION ISSUED. IT WAS MOVED BY ROY MOSELY, JR AND SECONDED BY C. DAVID TIEDEMANN TO ACCEPT HIS REPORTS AND PLACE IT ON FILE. MOTION CARRIED.

TOM KNAPP ALSO REPORTED THE ACCIDENT REVIEW BOARD MET TO REVIEW THE LAST QUARTER ACCIDENTS. THERE WERE 4 ACCIDENTS AND ONLY I WAS CHARGEABLE THE NOT CHARGEABLE. IT WAS MOVED BY DIXIE SEIBERT AND SECONDED BY C. DAVID TIEDEMANN TO ACCEPT ALL REPORTS. MOTION CARRIED.

FRANK BERGMAN REPORTED TO THE COMMITTEE THAT HE REVIEWED THE ACCIDENT REPORTS WITH NO CHANGES. IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY JERRY DINGES TO ACCEPT ALL REPORTS. MOTION CARRIED.

ANGELA GROSSMANN-ROEWE ASKED IF EVERYONE HAD RECEIVED THE 2017 PUBLIC SAFETY MEETING SCHEDULE AND THAT THIS WOULD BE HER LAST MEETING BUT SHE WOULD BE AROUND.

LINDA HARPER STATED SHE WOULD AMEND THE SCHEDULE FOR 2017 AND SEND OUT A NEW ONE CHANGING THE MAY DATE.

THERE BEING NO FURTHER BUSINESS, IT WAS MOVED BY JERRY DINGES AND SECONDED BY C. DAVID TIEDEMANN TO ADJOURN. MOTION CARRIED.
