1. Commissioner, St. Clair County Merit Commission:

Appointment of **REGINA RAY**to complete a six (6) year term effective Immediately and expiring on July 1, 2022.

Upon a motion by Mr. Easterley and seconded by Mr. Mosley, it was unanimously agreed to approve the 2016/2017 Tax Levy Ordinance.

➤ (St. Clair County) accepting the low bid for furnishing and delivering an estimated quantity of 10260 tons of rock salt for the 2016-2017 maintenance of County Highways, Road District Roads and Municipal Streets as included in Section 16-00000-00-GM.
