FRANK BERGMAN READ ALL THE CORRESPONDENCE FOR THE MONTH. IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY JERRY DINGES TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND REPORTS. MOTION CARRIED.

HERBERT SIMMONS REQUESTED THE EMA REPORT OF ACTIVITES FOR SEPTEMBER/OCTOBER 2016 BE PLACED ON FILE. IT WAS MOVED BY C. DAVID TIEDEMANN AND SECONDED BY ROY MOSLEY, JR. TO ACCEPT AND PLACE ALL CORRESPONDENCE AND EMA REPORT ON FILE. MOTION CARRIED.

LIEUTENANT LEE GRAHAM REPORTED THAT THE JAIL POPULATION AS OF 2:00PM THIS AFTERNOON (OCTOBER 24th) WAS 381 WITH THE RATE OF CAPACITY IS 418. HE ALSO STATED THAT THE SEPTEMBER 2016 JAIL REPORT, 618 INMATES ADMITTED, 163 WERE FEMALES, AND 455 WERE MALES, 235 OF THOSE ADMITTED WERE MISDEMEANORS, 209 OF THOSE WERE FELONIES AND 5 OF THOSE WERE FEDERAL.

LIEUTENANT GRAHAM ALSO REPORTED THE SEPTEMBER 2016 PATROL REPORT, 248 TRAFFIC STOPS, 129 TRAFFIC CIATAIONS ISSUED, 19 FELONY ARRESTS, 47 MISDEMEANORS ARREST, 127

COURTHOUSE PATROLS AND 501 PARK PATROLS. THE ENVIRONMENTAL DEPUTY MADE 59 ENVIRONMENTAL CONTACTS, OTHER DEPUTIES MADE 7 ENVIORNMENTAL CONTACTS FOR A TOTAL OF 66. THREE ENVIORNMENTAL CITATIONS WERE ISSUED. THE REST OF THE DEPARTMENTS MADE 11 FOR A TOTAL OF 72. IT WAS MOVED BY ROY MOSELY, JR AND SECONDED BY C. DAVID TIEDEMANN TO ACCEPT HIS REPORTS AND PLACE IT ON FILE. MOTION CARRIED.

FRANK BERGMAN REPORTED TO THE COMMITTEE THAT HE REVIEWED THE ACCIDENT REPORTS WITH NO CHANGES. IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY JERRY DINGES TO ACCEPT ALL REPORTS. MOTION CARRIED.

THERE BEING NO FURTHER BUSINESS, IT WAS MOVED BY C. DAVID TIEDEMANN AND SECONDED BY ROY MOSLEY, JR. TO ADJOURN. MOTION CARRIED.
