James Jacquot went over the statistic for March 2017.

James Jacquot asked members of SCCAWA if they have identified any of the cat places yet. They responded by saying they have test locations that they are working on. They are planning on attending the council meetings of the major towns, which are O'Fallon, Fairview Heights, and Belleville.

Mike O'Donnell asked if the grass has grown at the dog park. James Jacquot replied, it has actually grown nicely, and that there is water being installed. The fenced in area is for in house only, and that the Belleville Area Humane Society may use one side to walk their dogs.

SCCAWA asked how the outdoor kennels were coming along. James Jacquot stated that there may be a change with the outdoor kennels. The cost was a lot higher than they anticipated. They actually set aside one hundred twenty thousand dollars and that was not enough to do the job. There was going to be 10 kennels, the large cost is the electric and plumbing which has to be separate, due to the kennels cannot be attached to our building.
