9-a-5 ORDINANCE - AMENDING CHAPTER 21 - LIQUOR.

ORDINANCE NO. <u>17-1164</u>

AN ORDINANCE AMENDING CHAPTER 21 (LIQUOR) OF THE REVISED CODE OF ORDINANCES OF THE COUNTY OF ST. CLAIR, ILLINOIS.

WHEREAS, the Illinois Liquor Control Act of 1934 (235 ILCS 5/1-1, et seq.)(the "Act") governs the control and regulation of the manufacture, sale, and distribution of alcoholic liquors; and

WHEREAS, Section 4 of the Act provides that a county board, for the unincorporated area of the County, shall have the power by general ordinance or resolution to determine the number, kind and classification of licenses, for sale at retail of alcoholic liquor not inconsistent with this Act and the amount of the local licensee fees to be paid for the various kinds of licenses to be issued; and

WHEREAS, Section 4 of the Act provides that a county board, for the unincorporated area of the County, shall have the power to regulate or prohibit the presence of persons under the age of 21 on the premises of licensed retail establishments of various kinds and classifications where alcoholic liquor is drawn, poured, mixed or otherwise served for consumption on the premises; to prohibit any minor from drawing, pouring, or mixing any alcoholic liquor as an employee of any retail licensee; and to prohibit any minor from at any time attending any bar and from drawing, pouring or mixing any alcoholic liquor in any licensed retail premises; and to establish such further regulations and restrictions upon the issuance of and operations under local licenses not inconsistent with law as the public good and convenience may require; and

WHEREAS, in 2015, the Act was amended with regard to Sections 6-28 and 6-28.5 of the Act which provide for prohibited happy hours and permitted happy hours and meal packages, party packages, and entertainment packages; and

WHEREAS, St. Clair County desires to regulate the manufacture, sale, and distribution of alcoholic liquors within the unincorporated area of the County and issue appropriate licenses for the retail sale of alcoholic liquor; and

WHEREAS, the County Board of St. Clair County finds that it is in the best interests of the County and the public to regulate the classification of licenses for the retail sale of alcoholic liquor in the unincorporated area of St. Clair County; and

WHEREAS, the County Board of St. Clair County finds that it is in the best interests of the County to regulate the employment of persons under the age of twenty-one (21) in establishments licensed to sell alcoholic liquor in the unincorporated area of St. Clair County; and

WHEREAS, the County Board of St. Clair County finds that it is in the best interests of the County to conform its ordinances with the Act concerning prohibited happy hours and permitted happy hours and meal packages, party packages, and entertainment packages; and

WHEREAS, the County Board of St. Clair County finds that in order to establish and codify laws regarding the above issues, the County will amend Chapter 21 (Liquor) of its Code of Ordinances.

BE IT ORDAINED BY THE COUNTY BOARD OF ST. CLKAIR COUNTY, ILLINOIS, THAT:

SECTION 1: Amendment. Chapter 21, "Liquor" is hereby AMENDED to include new provisions which shall read as follows:

(EXHIBIT A ON FILE IN COUNTY BOARD OFFICE.)

Non-substantive changes, including but not limited to typographical errors, formatting and spacing errors, may be made to the amendment and Chapter 21 at the time this amendment is codified into the St. Clair County Code.

SECTION 2: Severability of Provisions. Each application shall include certification that any land clearing, construction, or development involving the movement of earth shall be in accordance with the plans approved upon issuance of the permit. A simplified form for single-family residential construction projects is available from the Building and Zoning Department.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE HOUSING AUTHORITY OF THE CITY OF EAST ST. LOUIS AND THE COUNTY OF ST. CLAIR, ILLINOIS, FOR THE APPOINTMENT OF AUXILIARY DEPUTIES.

This Intergovernmental Agreement is entered into by and between the Housing Authority of the City of East St. Louis, East St. Louis, Illinois (hereinafter "ESLHA"), the County of St. Clair, Illinois (hereinafter "SCC"), and the St. Clair County Sheriff (hereinafter "SCC Sheriff").

WHEREAS, Article VII, Section 10 of the Illinois Constitution provides that units of local government and public agencies may contract to share services through Intergovernmental Agreements; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 22011 et seq.) provides that public agencies may share powers through Intergovernmental Agreements; and

WHEREAS, ESLHA is a unit of local government and a public agency; SCC is a unit of local government that, by and through the SCC Sheriff, provides police protection and law enforcement services to and for SCC and its residents; and

WHEREAS, ESLHA is currently in receivership and the control of the U.S. Department of Housing and Urban Development; and

WHEREAS, ESLHA currently has in place a Non-Resident Ban and Bar Policy, which policy sets the process whereby non-residents may be refused entrance to a public housing property under certain circumstances;

WHEREAS, ESLHA employs public safety personnel on its property; and

WHEREAS, ESLHA, SCC and the SCC Sheriff desire that said public safety personnel be allowed to assist local law enforcement agencies with the enforcement of the Non-Resident Ban and Bar Policy and deterrence of disorderly conduct through the designation of ESLHA public safety personnel as auxiliary deputies of the SCC Sheriff on the terms and conditions provided herein; and

WHEREAS, pursuant to §3-6012 of the Illinois Counties Code Act the SCC Sheriff may, with the advice and consent of the SCC Board, appoint auxiliary deputies in such number as the County Board shall from time to time deem necessary, 55 ILCS 5/3-6012.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein and for other good and valuable consideration, ESLHA, SCC and SCC Sheriff agree as follows:

- Services: For the term of this Agreement, the SCC Sheriff shall appoint ESLHA public safety personnel, all or any number of them as the SCC Sheriff deems necessary from time to time, as auxiliary deputies of the SCC Sheriff in order to enforce the aforesaid Non-Resident Ban and Par Policy and to determ discordary, and the determinant of the school of 1. Services: Bar Policy and to deter disorderly conduct. The auxiliary deputies appointed pursuant to this Agreement shall be authorized to issue citations for violations of said policy as a complainant on behalf of ESLHA, and to issue citations for disorderly conduct and shall be further authorized to detain and/or transport any such suspect to local law enforcement agencies in connection with charging violations of the Non-Resident Ban and Bar Policy and disorderly conduct. ESLHA shall at all times be an independent contractor under this Agreement, and the auxiliary deputies appointed pursuant to this Agreement shall at all times employees of ESLHA and shall not be deemed employees of SCC and/or SCC Sheriff.
- Training: Any and all training necessary for appointment of ESLHA public safety personnel as
- auxiliary deputies shall be determined and provided by the SCC Sheriff.

 Indemnification/Insurance: ESLHA shall indemnify and hold harmless SCC and the SCC Sheriff from and against any and all liability and/or claims caused by negligence or willful misconduct on the part of ESLHA security personnel related to their duties and responsibilities as auxiliary deputies and the performance of the terms of this Intergovernmental Agreement. ESLHA shall add SCC and SCC Sheriff as additional insureds on its policy of Furthermore,
- general liability insurance.

 4. Compensation: ESLHA shall be solely responsible for any and all compensation paid to its public safety personnel for services provided under this Intergovernmental Agreement.
- Term/Termination: The term of this Intergovernmental Agreement shall commence upon execution hereof and shall remain in full force and effect until terminated by any party hereto with thirty (30) days written notice.
- 6. Strict Compliance: No failure by any party to insist upon the strict performance of any covenant, term or condition of this Intergovernmental Agreement, or to exercise any right or remedy upon a breach thereof, shall constitute a waiver of any such breach or any subsequent breach of such covenant, term or condition. WHEREAS, it is the public policy of the State of Illinois to secure for all individuals within Illinois, freedom from unlawful discrimination in employment, including freedom from sexual harassment and discrimination based on pregnancy status; and

it is the public policy of the State of Illinois to protect Illinois citizens against unfounded charges of unlawful discrimination and sexual harassment in employment; and

WHEREAS, it is the policy of St. Clair County to protect its employees from unlawful discrimination, including freedom from sexual harassment and discrimination based on pregnancy status; and

WHEREAS, it is the policy of St. Clair County to protect its employees against unfounded charges of unlawful discrimination and sexual harassment; and

WHEREAS, the Illinois Human Rights Act has been amended by the Illinois General Assembly; and

WHEREAS, the St. Clair County Board finds that it is in the best interests of the County to conform its Personnel Code with the relevant and current provisions of the Illinois Human Rights Act; and

WHEREAS, the County Board of St. Clair County finds that in order to establish and codify laws relating to the above issues, the County will amend and revise Chapter 28 (Personnel Code) of its Revised Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD OF ST. CLAIR COUNTY, ILLINOIS, THAT:

SECTION I: Amendment. Chapter 28, "Personnel Code" is hereby AMENDED to include new provisions which shall read as follows:

SECTION II: Inconsistent Ordinances Repealed. All ordinances or parts of other Ordinances in conflict with the provisions of this Ordinance shall, to the extent of the conflict, be, and are hereby repealed, provided that nothing herein shall in any way excuse or prevent prosecution of any previous existing violation of any Ordinance superseded hereby.

SECTION III: Saving Clause. Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed by this Ordinance, nor shall any just or legal right or remedy of any character be lost, impaired, or affected by the Ordinance.

SECTION IV: Passage and Publication. This Ordinance shall be in full force and effect from its passage of publication by the County Clerk as provided by law and shall continue in effect and operation until lawfully repealed by the St. Clair County Board.

SECTION V: Severability of Provisions. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remained of the Ordinance, nor any part thereof, other than that part affected by such decision.
