JOHN HUGHES READ ALL THE CORRESPONDENCE FOR THE MONTH. IT WAS MOVED BY ROY MOSLEY AND SECONDED BY KEVIN DAWSON TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND REPORTS. MOTION CARRIED.

HERBERT SIMMONS READ HIS EMA REPORT TO THE COMMITTEE. MR. SIMMONS ALSO NOTED THAT FOR THE FIRST TIME EMA HAS RECEIVED A PERFESSIONAL DEVELOPMENT CERTIFICATION. WE COMPLETED ALL CERTIFICATION. CERTIFICATES COME LATER THIS YEAR FROM SPRINGFIELD. WE HAD AN APPRECIATION DAY FOR ALL TELECOMMUNICATORS IN THE COUNTY.

CHAIRMAN KERN AND I ATTENDED A MEETING IN FAIRVIEW HEIGHTS WITH THE DIRECTOR OF IEMA ON FLOOD PLANNING FOR THIS YEARS FLOODING EVENTS. I AM HAPPY TO SAY THEY ARE NOT PREDICTING ANYTHING TO BAD.

ROY MOSLEY, JR. CONGRADULATED HERBERT SIMMONS ON THE EMAS CERTIFICATION.

TOM KNAPP STATED THE JAIL POPULATION THIS AFTERNOON AT 2:00 WAS 370 THE DOC RATE IS 418 SO WE ARE DOING GOOD.

TOM KNAPP APOLOGIZED HE LEFT THE JAIL ACTIVITY REPORT AT THE OFFICE SO HE WILL REPORT IT NEXT MEETING. PATROL FOR THE MONTH, THERE WAS 405 TRAFFIC STOPS, 13 FELLONY ARREST, 34 MISDEMEANORS ARREST, 40 WARRANT ARREST. 302 COURT HOUSE CHECKS, 656 PARK PATROLS AND A TOTAL OF 7814 POINTS OF CONTACT WITH GENERAL PUBLIC. ENVIORNMENTAL GUY HAD 111 CONTACTS MADE, 25 POINTS OF CONTACT.

IT WAS MOVED BY STEVEN GOMRIC AND SECONDED BY ROY MOSLEY TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.

STEVEN GOMRIC ASKED TOM KNAPP FOR A REPORT OF HOW MANY LAW SUITES PAID OUT RELATED TO THE JAIL OVER THE LAST YEAR.

TOM KNAPP WILL HAVE THE INFORMATION STEVEN GOMRIC ASKED FOR AT OUR NEXT PUBLIC SAFETY MEETING.

FRED BOCH ASKED IF WE AN RFP ON WHAT IT WOULD COST TO BUILD A NEW JAIL?

CHAIRMAN KERN STATED WE DID THAT NUMBER ABOUR 4 OR 5 YESARS AGE WHEN SHERIFF JUSTUS WAS THERE SO WE HAVE A PRETTY GOOD IDEA. THE SHERIFF MAY HAVE A DIFFENENT UMBER AS TO WHAT WE HAD AROUND FIFTY TO SEVENTY MILLION DOLLARS.

FRED BOCH ASKED IF WE HAD PURCHASED LAND.

TOM KNAPP STATE THEY HAVE PURCHASED HOME ACROSS THE STREET AND DEMOLISHED THEM. IT EXTENDS ACROSS FIFTH STREED TOWARD THE PARK.

THERE BEING NO FURTHER BUSINESS, IT WAS MOVED BY ROY MOSLEY, JR AND SECONDED BY KEVIN DAWSON TO ADJOURN. MOTION CARRIED.
