ROLL CALL FOR THE AUGUST 28, 2017 PUBLIC SAFETY MEETING.

JERRY DINGES ASKED IF THERE WERE ANY COMMENTS FROM THE PUBLIC REGARDING THE MEETINGS AGENDA. NO COMMENTS MADE.

IT WAS MOVED BY MICHAEL O'DONNELLAND SECONDED BYROY MOSLEY, JR.TO APPROVE THE JULY 31, 2017 MINUTES. MOTION CARRIED.

FRANK BERGMAN READ ALL THE CORRESPONDENCE FOR THE MONTH.IT WAS MOVED BY ROY MOSLEY, JR.AND SECONDED BYKEVIN DAWSONTO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCEAND REPORTS. MOTION CARRIED.

HERBERT SIMMONS PRESENTED HIS EMA REPORT OF ACTIVITIES. HE ALSO STATED A YOUNG MAN FROM MILLSTADT WHO HAD DONE A TOUR WITH US FOUND HIMSELF CALLING 911. HE GOT HIT IN THE HEAD WITH A BASEBALL BAT. CHANNEL 4 COVERED THAT FOR US. WE ATTENDED SEVERAL MEETINGS IN SPRINGFIELD WITH THE ADVISORY BOARD AS RECENTLY AS TODAY.

THE MOBILE COMMAND POST WAS DEPLOYED TO FAIRVIEW HEIGHTS FOR THEIR HOME COMING ANNUAL PICNIC. WE WERE ALSO IN FREEBURG AND AT THE RACE TRACK IN MADISON. THE PAST WEEKEND WE WERE BUSY WITH THE ECLIPSE.

WE HAD A THIRD MEETING OF THE COUNTY LITIGATION MEETING WHICH IS A REQUIREMENT FOR ALL COMMUNITIES. THEY MUST ATTEND ONE OF FIVE MEETINGS FOR THE COUNTY TO KEEP THE LITIGATION PLAN IN PLACE FOR THREE YEARS. WE ARE DOWN TO FOUR COMMUNITIES THAT HAVEN'T ATTENDED THE MEETINGS THEY HAVE TWO MORE MEETINGS TO ATTEND OR OTHERWISE IF THERE WHERE TO BE A DISASTER IN THAT COMMUNITY THEY WOULD BE EXEMPT FROM FEDERAL FEMA REIMBURSEMENT. I'M WORKING WITH THOSE FOUR COMMUNITIES TO GET THEM REPRESENTED AT THE NEXT TWO MEETINGS.

ROY MOSLEY ASKED WITH ALL THE FLOODING GOING IN THE TEXAS DISASTER ARE READY? ARE WE HELPING THEM?

HERB SIMMONS STATED WE HAVE EQUIPMENT BEING STAGED TO BE DEPLOYED. MISSOURI HAS CALLED AND THEY ARE COMPILING A LIST. WE ARE SENDING SOME OF OUR SWIFT WATER RESCUE BOATS THERE.

CHAIRMAN MARK KERN STATED WE ARE THEN PROVIDING BACKUP FOR MISSOURI FOR THOSE WHO HAVE GONE. IT WAS MOVED BY PAUL SEIBERT AND SECONDED BY ROY MOSLEY, JR. TO ACCEPT THE EMA REPORT AND PLACE IT ON FILE. MOTION CARRIED.

TOM KNAPP STATED THE JULY AVERAGEPOPULATION COUNTS 411 DOC RATE IS 418. AS OF 2:00PM THIS AFTERNOON WAS DOWN TO 375. JAIL ADMITTED 617 DETAINEES IN JULY, 183 FEMALES, 134 MALES, 244 MISDEMEANORS, AND 196 FELONIES. ON THE ROAD SIDE 342 TRAFFIC STOPS ISSUED, 195 CITATIONS ISSUED, 20 FELONY ARREST, 39 MISDEMEANORS ARREST AND 42 WARRANT ARREST. 266 COURT HOUSE CHECKS, 596 PARK PATROLS TOTALING 7249 POINTS OF CONTACT WITH THE GENERAL PUBLIC.

CHAIRMAN MARK KERN ASKED ARE WE STILL DOING THE DUI PARTROL.

TOM KNAPP STATED THAT GRANT WAS GONE.IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY MIKE O'DONNELL TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.

FRANK BERGMAN REPORTED THE ACCIDENT REPORTS FOR JULY OF 2017. THERE BEING NO QUESTIONS IT WAS MOVED BY MICHAEL O'DONNELL AND SECONDED BY STEVE GOMRIC TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.

THERE BEING NO FURTHER BUSINESS, IT WAS MOVED BYROY MOSLEY, JR.AND SECONDED BY STEVE GOMRICTO ADJOURN. MOTION CARRIED.
