SECTION I: Amendment. Chapter 8 and the following articles and sections:

ARTICLE VI RAFFLES

SECTION 8-6-11 "QUEEN OF HEARTS RAFFLES TERMS AND FEES" [NEW SECTION]

Is hereby AMENDED to read as follows

"ARTICLE VI RAFFLES

8-6-11 QUEEN OF HEARTS RAFFLES TERM AND FEES.

- (A) The following terms and fees apply to raffles which are designated as "Queen of Hearts" raffles. All other provisions of Article VI which do not conflict with the following terms and fees also apply to "Queen of Hearts" raffles.
- The aggregate retail value of all prizes or merchandise awarded by a licensee in a single raffle shall not exceed Five Hundred Thousand Dollars (\$500,000.00);
- The maximum retail value of each prize awarded by a licensee in a single raffle shall not exceed Five Hundred Thousand Dollars (\$500,000.00);
- The maximum price which may be charged for each raffle chance issued or sold shall not exceed Twenty-Five Dollars (\$25.00);
- The maximum number of weeks during which chances may be issued or sold shall not exceed Fifty-Four (54) weeks;
- Licenses issued pursuant to this Ordinance shall be valid for one (1) Queen of Hearts raffle and may be suspended or revoked for any violation of this Ordinance;
- Raffle chances shall be sold only within the boundaries of the County and outside the boundaries of any municipality;
- Licenses to conduct a "Queen of Hearts" raffle shall be issued to bona fide religious, charitable, labor, fraternal, educational, or veterans' organizations that operate without profit to their members, and which have been in existence continuously for a period of five (5) years immediately before making application for a license and which have had during that entire five (5) year period a bona fide membership engaged in carrying out their objectives;
- The above-mentioned types of organizations shall be defined pursuant to the General Assembly Act, House Bill 2976, and incorporated herein;
- No person or organization shall be issued more than one (1) license in a period of one (1) week;

- (K) The manager of a Queen of Hearts raffle game shall give a fidelity bond in the sum of Twenty-Five Thousand Dollars (\$25,000.00) in favor of the organization conditioned upon his honesty in the performance of his duties. The Chairman of the County Board or his designated representative is authorized to waive requirement for bond by including a waiver provision in the license issued, provided that the license containing such waiver provision shall be granted only by unanimous vote of the members of the licensed organization. The terms of the bond shall provide that notice shall be given in writing to the licensing authority not less than thirty (30) days prior to its cancellation.
- (L) Any license issued under this Ordinance shall be non-transferable.
- (M) Fees. The fee for a "Queen of Hearts" raffle license issued under this Chapter shall be Twenty-Five Dollars (\$25.00) each time a license is issued. The license issued pursuant to this Ordinance for a "Queen of Hearts" raffle shall be valid for one (1) raffle until the "Queen of Hearts" is selected and shall be conducted during a specified period not to exceed fifty-four (54) weeks and may be suspended or revoked for any violation of this Ordinance.
- (N) All operation of and the conduct of Queen of Hearts raffles shall be under the supervision of a single manager designated by the organization."

SECTION II: SAVING CLAUSE. Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed by this Ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by the Ordinance.

SECTION III: PASSAGE AND PUBLICATION. This Ordinance shall be in full force and effect from its passage of publication by the County Clerk as provided by law and shall continue in effect and operation until lawfully repealed by the St. Clair County Board.
