The regular meeting of the Environment Committee of the St. Clair County Board was called to order on Tuesday, February 21, 2017 in the St. Clair County Board Conference Room, #10 Public Square, Belleville, Illinois, by Chairman, Dave Tiedemann.

Belleville Recycling will handle the recycling of the books for \$40.00/ton. Last year 10.61 tons of phone books were collected in three months.
