JANET G. LINTON, DVM, ADMINISTRATOR/ANIMAL CONTROL, 1600 North Belt East, Belleville, Illinois, 62221, and the ST. CLAIR COUNTY BOARD, hereby enter into a CONTRACT FOR SERVICES under the terms and conditions described below:

- GENERAL PROVISIONS:

 1) The Contract shall begin on JANUARY 1, 2017 and terminate on DECEMBER 31, 2017.
- 2) The Contract may be renewed on an annual basis with the written consent of both parties, notice of intent by both parties to be provided prior to the 1st day of December each year. The Contract may be terminated by either party, with or without cause, upon provision of sixty

- 4) The Administrator will be an independent contractor and not an employee of ST. CLAIR COUNTY for any purpose whatever.
- terms and conditions contained in this document constitute the entire agreement of the parties and may only be supplemented, deleted or altered by mutually agreed modification.

II. RESPONSIBILITIES, DUTIES, AND POWERS OF ANIMAL CONTROL ADMINISTRATOR:

- The Administrator will be a currently licensed veterinarian in the State of Illinois. The Administrator shall perform all statutory duties enumerated in 510 ILCS 5/5. The Administrator shall have all police power as defined in 510 ILCS 5/5.

- The Administrator shall provide emergency treatment services as defined by standard veterinary practice for all animals received in the Animal Services Department during normal office operating hours.
- The Administrator will prepare laboratory specimens for shipment as needed.
- The Administrator will vaccinate all quarantined animals for the sum of \$16.00 per animal. The Administrator will provide pre-release examinations for all quarantined animals for the
- sum of \$16.00 per animal.
- 8) The Administrator shall provide spay/neuter surgeries for the Pet Population Clinic animals at a fee of \$55.00 per animal.
- The Administrator shall provide spay/neuter surgeries for the Adoption Center animals at a cost not to exceed \$75.00 per animal unless pre-approved by the Director.
- 10) The Administrator will respond to all public inquiries regarding the care of quarantined animals.
- 11) The Administrator will provide liability insurance for any and all activities undertaken on behalf of ST. CLAIR COUNTY naming ST. CLAIR COUNTY as a named insured.12) The Administrator will provide such written or oral reports as may be required by the ST.
- CLAIR COUNTY BOARD and/or the State of Illinois.

DUTIES AND RESPONSIBILITIES OF ST. 1) ST. CLAIR COUNTY will pay ADM:

- ST. CLAIR COUNTY will pay ADMINISTRATOR the sum of NINETEEN THOUSAND, TWO HUNDRED AND NO/100 DOLLARS (\$19,200.00) per annum, in equal monthly installments of ONE THOUSAND, SIX HUNDRED AND NO/100 DOLLARS (\$1,600.00) payable to Belleville Animal Clinic, said remuneration to be payment in full for all services and expenses except as noted in Section II (5) and (6) of this Contract.

A RESOLUTION DENYING A REQUEST FOR A SPECIAL USE PERMIT BY BRADLEY K. CURTIS & DEBRA S. CURTIS, AS CO-TRUSTEES UNDER THE CURTIS FAMILY TRUST, OWNERS, AND MADD TOWING, INC. DBA DOUBLE D AUTO, APPLICANTS, FOR PROPERTY LOCATED AT 3211 BEARE LANE, MILLSTADT, ILLINOIS, IN MILLSTADT TOWNSHIP. (2016-07-SP)

WHEREAS, the Zoning Board of Appeals, after considering the evidence and testimony presented at the previous hearings, the testimony and evidence presented on November 7, 2016 and December 5, 2016, after considering all relevant sections of the St. Clair County Zoning Code, and after further consideration of the matter, denied the applicant's a Special Use Permit for a Planned Building Development pursuant to Section 40-9-3(H)(3) to allow an Auto Repair/Rebuilder in an "A" Agricultural Industry Zone District for the following reasons: The applicant, as well as, the owner of the property in question, are requesting that they be allowed to operate a commercial auto repairer/rebuilder business on property that is currently the Curtis's residence located in a rural area of St. Clair County, thus, creating a dual use upon the property. The property in question is a wooded residential lot, which is located in

an Agricultural Industry District. The make-up of the surrounding area is rural in nature consisting of agricultural fields and woods, and residential uses. The roads in this area and leading to the of agricultural fields and woods, and residential uses. The roads in this area and leading to the property in question are rural, unmarked rock based township roads that are narrow and winding in nature. There is no public water or sewers to the property in question. The proposed use will not adequately protect the public's health, safety and welfare and the physical environment; the proposed use of this property as both the Curtis's residence and an unrelated company's body shop or repair/rebuild facility is not in harmony with the zoning code; the zoning of the property in question, and the current zoning and uses of the surrounding area. There are no similar type commercial businesses in the immediate vicinity. There does not exist public water or sewer services to the property in question. Further the roads in this area are not adequate to accommodate commercial traffic. The proposed use is not consistent with the Comprehensive Plan, as the plan calls for Agricultural Preservation. The placement of a use that is not in conformity with the zoning or the general make-up of the area surrounding the proposed use or a use that cannot be served adequately by general make-up of the area surrounding the proposed use or a use that cannot be served adequately by public utilities and readways and creates an adverse affect on the value of the neighboring property and the County's overall tax base. Commercial traffic to and from a business in the rural and noncompatible with the adjacent uses in the general vicinity, as everyday noises and dealings associated with commercial business are not compatible with the rural agricultural and residential uses. Further, there are no particular or unique characteristics of the proposed special use or the property in question that would be compatible and would not have an adverse effect on the adjacent property or the general neighborhood.

WHEREAS, the County Board of St. Clair County, Illinois, have considered the aforementioned matter and the findings, conditions, and recommendations of the Zoning Board of Appeals and hereby unanimously agree with the Zoning Board of Appeals' recommendation and denies the Special Use Permit (2016-07-SP)

Dear Mr. Allev:

RJN Group, Inc. (RJN) is pleased to present this proposal to provide necessary Phase II storm water monitoring implementation assistance from October 2016 through February 2017, which will coincide with Year 3 of the five-year permit period. Per the National Pollutant Discharge Elimination Systems Year 3 of the five-year permit period. Per the National Pollutant Discharge Elimination Systems (NPDES) ILR40 permit effective March 1, 2016, the permittee shall "develop and implement a monitoring and assessment program to reduce pollutant loadings and water quality impacts." The program plan and its results are to be included in the Annual Report due June 1, 2017.

For the purpose of this proposal, the term "municipality" describes St. Clair County, townships, cities, and villages participating in the St. Clair County MS4 Co-Permittee group.

Municipalities serving populations over 25,000 must evaluate storm water quality using 1 of the 10 methods outlined in NPDES Permit Part V.A.2b. NPDES Permit Part V.A.2.b methods include analysis of total suspended solids, total nitrogen, total phosphorous, fecal coliform, chlorides, and oil and grease. Additionally, "monitoring shall be performed for any other pollutants associated with storm water runoff for which the receiving water is considered impaired pursuant to the most recently approved list under Section 303(d) of the Clean Water Act."

Section 303(d) of the Federal Clean Water Act requires states to identify waters that do not meet applicable water quality standards. The Illinois Environmental Protection Agency (IEPA) has developed a Total Maximum Daily Load (TMDL) for each pollutant of an impaired water body. The TMDL determines the load, or quantity, of any given pollutant that can be allowed in a particular water body and can affect storm water testing requirements for municipalities over 25,000 persons.

SCOPE OF SERVICES

RJN will help develop a program that will include, but is not limited to, the following:

RJN will work closely with the IEPA to develop guidelines for program implementation and possible TMDL pollutant testing.

- Researching and assisting St. Clair County in developing a monitoring and assessment program to
 evaluate the effectiveness of the BMPs being implemented to reduce pollutant loadings and water
 quality impacts.
- Providing a plan in cooperation with St. Clair County for storm water evaluation, its justification, and its results in the Annual Report, standardized where applicable and customized to include unique details of each community's results.

IMPLEMENTATION SCHEDULE

RJN will coordinate efforts with St. Clair County and the IEPA to have a program in place by December 31, 2016, and to begin water sample monitoring with the new permit year beginning March 1, 2017.

ESTIMATED FEE

RJN is prepared to perform the services stated above at the lump-sum fee of \$2,020. This fee is in addition to the annual St. Clair County MS4 program fee and does not include laboratory testing of water samples.

WATER SAMPLING SERVICES

RJN can provide sample taking and testing services at a cost of \$525 per site visit. The service would include taking a sample once per quarter at each designated outfall within 48 hours of a rainfall event greater than or equal to one quarter inch in a 24-hour period using standard sampling methods and materials, delivering samples to a local laboratory for analytical services, and providing the municipality with copies of the chain of custody forms and testing results. Laboratory tests would include the following pollutant analyses: total suspended solids, total nitrogen, total phosphorous, fecal coliform, chlorides, and oil and grease. Designated outfalls are to be identified for testing by each municipality annually. Additional laboratory charges would result for tests required by local TMDL levels.

Fees for services are outlined below.
