1. **MINUTES**:

A motion was made and seconded to approve the minutes of the June 21, 2017 Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. **Revolving Account Activity**: The Revolving Account Activity Report for June 2017 shows a Beginning Balance of \$10,623.42, Total Disbursements of \$11,886.72, Receipts of \$8,309.61, Allocated Pool Interest in the amount of \$7.61 with a Balance at Month End of \$7,053.92.

5. OTHER BUSINESS:

Mr. Heiligenstein noted there are 3 parcels in Fayetteville and one of the parcels is 18 inches wide by something. Mr. Heiligenstein inquired if the minimum of \$750.00 is the best we can do on an 18 inch piece of property. The Village of Fayetteville wants to buy all three parcels if we can clear them up. Discussion ensued regarding the purchase of all three parcels. The village would like to purchase the property to get it off the books. Mr. Strohmeyer suggested offering the two parcels that are adjoining as one minimum and the minimum for the other one to offset. Mr. Heiligenstein stated he would check with the Village of Fayetteville.
