> St: Clair County Parks Grant Commission:

The usual completion of projects, requests for extensions and the payment of invoices for Cycle 22 and 23 have been processed during the last month. St: Clair County Parks Grant Commission has scheduled a meeting for June 30, 2017 regarding the Cycle 24 park grant.
