AN ORDINANCE AMENDING CHAPTER 3, THE ANIMAL SERVICES CODE OF THE COUNTY CODE OF ORDINANCE OF ST. CLAIR COUNTY, ILLINOIS

BE IT ORDAINED BY THE COUNTY BOARD OF ST. CLAIR COUNTY, ILLINOIS, THAT:

SECTION I: AMENDMENT. Chapter 3 and the following articles and sections:

ARTICLE 1 GENERAL PROVISIONS

Section 3-1-2 "DEFINITIONS"

is hereby ${\tt AMENDED}$ to read as follows and

ARTICLE VII MANAGED CARE OF FERAL CATS (NEW SECTION)

SECTION 3-7-1 "PURPOSE" (NEW SECTION)

SECTION 3-7-2 "COMMUNITY CATS" (NEW SECTION)

SECTION 3-7-3 Effective 09/27/2017 (NEW SECTION)

New Article VII is added:

ARTICLE I GENERAL PROVISIONS

3-1-2 DEFINITIONS.

COMMUNITY CAT. "Community Cat" means any free-roaming, feral, or barn cat that may be cared for by one or more residents of the immediate area and which has no discernible form of ownership identification. "Community cat" includes a domesticated cat that an owner has forsaken entirely or neglected or for which an owner has refused to provide care and support.

COMMUNITY CAT CAREGIVER. "Community Cat Caregiver" means a person who provides care, including food, water, shelter or medical care to a community cat. A community cat caregiver shall not be considered to be the owner, custodian, harborer, controller, or keeper of a community cat.

FERAL CAT. "Feral Cat" means a cat that (i) is born in the wild or is the offspring of an owned or feral cat and is not socialized or (ii) is a formerly owned cat that has been abandoned and is no longer socialized, or (iii) lives on a farm.

ARTICLE VII MANAGED CARE OF FERAL CATS

3-7-1 PURPOSE: To permit implementation of a community cat program (CCP) in St. Clair County, Illinois (County) for the purpose of reducing the population of feral and free roaming cats, benefitting public health, improving the quality of life for residents, and ensuring the humane treatment of community cats.

3-7-2 COMMUNITY CATS:

- a) The Board established the following community cat requirements:
 - i) All community cats must be cared for on the private property of the caregiver or with the permission from the owner or property manager if cared for on the property of another.
 - ii) All community cat caregivers shall make reasonable efforts to have all freeroaming cats within their care sterilized, vaccinated against rabies, and eartipped for easy identification.
 - All community cat caregivers are required to make reasonable efforts to provide certain necessities to each community cat under his/her care on a regular/ongoing basis, including, but not limited to, proper nutrition, adequate quantities of visibly clean and fresh water and medical care as needed. If medical care is unavailable or too expensive, the community cat caregiver must not allow the cat to suffer. Dumping on the ground or dispensing large quantities of food more than will be immediately eaten by the community cats present is prohibited. Feeding areas must be maintained in a clean and sanitary condition.
 - iv) Community cat caregivers shall make reasonable attempts to remove young kittens from the field for domestication.
- (b) Community cats meeting the requirements of this section are exempt from any licensing requirements under 3-3-1 of Chapter 3 of the County Code of Ordinances.
- (c) The Administrator shall have the right to remove or authorize the removal of any free-roaming cat or community cat because of immediate public health or safety concerns.
- (d) No community cat shall be released at any governmentally owned or managed park, natural area, area deemed as environmentally sensitive land or on any easement adjacent to such lands without approval from the Administrator.
- lands without approval from the Administrator.

 (e) Healthy community cats that have been impounded by the Administrator are exempt from the holding period referenced in Section 3-4-4 of Chapter 3 of the County Code of Ordinances and shall be immediately returned to the location at which they were found, released to a caregiver or adopted. Before being returned to the location at which they were found or released to a caregiver, community cats shall be sterilized, ear tipped while under anesthesia under the supervision of a licensed veterinarian, and vaccinated for rabies. Notwithstanding the foregoing, whenever such cat is visibly injured or diseased and appears to be suffering and it reasonably appears that such cat cannot be expeditiously cured and returned to the field, transferred to a humane society or private animal nonprofit organization or placed in foster care, then the Administrator, acting in good faith and upon reasonable belief, my humanely euthanize the cat upon the advice of a licensed veterinarian.
- (f) Community cats released to a caregiver in accordance with Subsection (e) shall not be subject to the requirements of Section 3-4-4(A)-(D) of Chapter 3 of the County Code of Ordinances.
- (g) Community cat caregivers shall not be subject to the provisions of Section 3-4-17 of Chapter 3 of the County Code of Ordinances, provided that permission from the property owner has been obtained to care for community cats on the property.

3-7-3 Effective 09/27/2017

SECTION II: INCONSISTENT ORDINANCES REPEALED. All ordinances or parts of other Ordinances in conflict with the provisions of this Ordinance shall, to the extent of the conflict, be, and are hereby repealed, provided that nothing herein shall in any way excuse or prevent prosecution of any previous existing violation of any Ordinance superseded hereby.

SECTION III: SAVING CLAUSE. Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed by this Ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by the Ordinance.

SECTION IV: PASSAGE AND PUBLICATION. This Ordinance shall be in full force and effect from its passage of publication by the County Clerk as provided by law and shall continue in effect and operation until lawfully repealed by the St. Clair County Board.

9-b-2 ORDINANCE NO. 17-1161 - AMENDING CHAPTER 7 (BUILDING CODE) - POSTPONED.

9-b-3 ORDINANCE - AMENDING CHAPTER 8 (BUSINESS REGULATIONS).

ORDINANCE NO. 17-1162

AN ORDINANCE AMENDING CHAPTER 8 (BUSINESS REGULATIONS), OF THE REVISED CODE OF ORDINANCES OF THE COUNTY OF ST. CLAIR, ILLINOIS.

WHEREAS, the Illinois Video Gaming Act (230 ILCS 40/1, et seq.) (the "Act") legalizes the use of video gaming terminals in certain qualified establishments throughout the State of Illinois; and

WHEREAS, Section 27 of the Act provides that a County Board may, for the unincorporated area of the County, pass an Ordinance prohibiting video gaming within the unincorporated area of the County; and

WHEREAS, Section 65 of the Act provides that a non-home rule unit of government may not impose a fee for the operation of a video gaming terminal in excess of \$25.00 per year; and

WHEREAS, St. Clair County desires to regulate video gaming terminals within the unincorporated area of the County and impose a fee per video gaming terminal; and

WHEREAS, the County Board of St. Clair County finds that it is in the best interests of the County and the public to regulate the location of video gaming terminals in the unincorporated area of St. Clair County; and

WHEREAS, the County Board of St. Clair County finds that it is in the best interests of the County to establish a licensing system for video gaming terminals and license video gaming terminals in the unincorporated area of St. Clair County, and impose an annual fee not in excess of Twenty-Five Dollars and Zero Cents (\$25.00)(or the maximum amount allowed by the laws of the State of Illinois) for the operation of an individual video gaming terminal by a terminal operator within the County's limits; and

WHEREAS, the County Board of St. Clair County finds that in order to establish and codify the aforementioned licensing system the County will amend Chapter 8 (Business Regulations) of its Revised Code of Ordinances to create a new article - "Article VIII - Video Gaming" - that will license video gaming terminals within the unincorporated area of St. Clair County.

BE IT ORDAINED BY THE COUNTY BOARD OF ST. CLAIR COUNTY, ILLINOIS, THAT:

SECTION 1: AMENDMENT. Chapter 8, "Business Regulations" is hereby AMENDED to include a new article - "Article VIII - Video Gaming" - which shall read as follows:

ARTICLE VIII - VIDEO GAMING

8-8-1 AUTHORITY TO REGULATE. This Article is passed pursuant to 230 ILCS 40/1, et seq., (the Illinois Video $Gaming\ Act)$.

8-8-2 <u>DEFINITIONS</u>. For the purpose of this Article, the following definitions shall apply unless the context <u>clearly ind</u>icates or requires a different meaning.

CONVENIENCE STORE: A retail store or business that carries or stocks a limited selection of basic items, such as packaged food, groceries (i.e., milk and bread), snack foods, confectionery items, soft drinks, coffee, tobacco products, packaged alcohol or liquor (not to be consumed on premise), over-the counter drugs, toiletries, newspapers and magazines, and is open long hours for the convenience of shoppers. A Convenience Store may or may not sell gasoline, diesel fuel, or petroleum products.

LICENSED ESTABLISHMENT: Shall have that definition as set forth in the Illinois Video Gaming Act, 230 ILCS 40/5.

LICENSED FRATERNAL ESTABLISHMENT: Shall have that definition as set forth in the Illinois Video Gaming Act, 230 ILCS 40/5.

LICENSED TRUCK STOP ESTABLISHMENT: Shall have that definition as set forth in the Illinois Video Gaming Act, 230 ILCS 40/5.

LICENSED VETERANS ESTABLISHMENT: Shall have that definition as set forth in the Illinois Video Gaming Act, 230 ILCS 40/5.

PERSON: As used herein shall include any person, firm, corporation or association, or partnership which, as permitted by state law and regulation, owns or possesses or places for use by the public any video gaming terminal, and shall also mean any such person, firm, corporation, partnership or association having control over any video gaming terminal.

PREMISES: A lot together with all the buildings and uses thereon. A "lot" shall mean a portion or parcel of land (whether a portion of a platted subdivision or otherwise) officially authorized and recorded in the office of the Recorder of Deeds which is occupied or intended to be occupied by a building or use and its accessories together with such yards as are required under the provisions of the St. Clair County Zoning Code (40-1-1 et seq.). The work "lot" shall include the words "plot", "piece", "tract", or "parcel".

VIDEO GAMING TERMINAL: Shall have that definition as set forth in the Illinois Video Gaming Act, 230 ILCS 40/5.

8-8-3 <u>LICENSE REQUIRED</u>. No person shall own, possess, keep or display for use or patronage by the public within the unincorporated area of St. Clair County, any video gaming terminal without having first obtained a license from St. Clair County, through the St. Clair County Clerk's office, and said license shall be framed and hung in plain view in a conspicuous place on the licensed premises. The

posted license may include more than one terminal on the licensed premises. It shall be a prerequisite to any potential licensee that the person have a valid license from the State of Illinois for each video gaming terminal. The loss or suspension of any license issued by the State of Illinois for such video gaming terminal(s) shall automatically result in the loss and suspension of the license issued by St. Clair County, without hearing and without refund of any license fee. Pursuant to state regulation, St. Clair County, through either the County Clerk or County Sheriff, shall report to the State of Illinois any discipline or change in status of any video gaming licenses issued by St. Clair County.

- 8-8-4 <u>LICENSE FEE.</u> The yearly license fee per video gaming terminal shall be Twenty-Five Dollars (\$25.00) or the maximum amount allowed by the laws of the State of Illinois for each video gaming terminal upon a premises, up to a maximum of five (5) video gaming terminals per licensed premises. (See 230 ILCS 40/65.) The license fee shall not be prorated.
- 8-8-5 <u>LICENSE APPLICATION</u>. License application shall be made upon the prescribed license application form adopted by the St. Clair County Clerk.
- 8-8-6 <u>TIME OF APPLICATION AND TERM OF LICENSE</u>. Applications for a license pursuant to this Article shall be submitted at least thirty (30) days prior to the commencement of the period for which the license is sought. The term of license granted under this Article shall commence on the date in which the license is issued and shall expire on December 31st of the same year in which the license is issued, unless terminated earlier pursuant to (i) this Article, (ii) for violations of the St. Clair County Liquor Code (21-1-1, et seq.), (iii) violations of the Illinois Video Gaming Act (230 ILCS 40/1, et seq.), or (iv) violations of any other applicable code, regulation, or law. Application for a license must be made annually.
- 8-8-7 $\underline{\text{LICENSE NOT TRANSFERABLE}}$. No license issued to any person hereunder shall be transferable to any other person or for any other premises other than as set forth on the license.
- 8-8-8 <u>NUMBER OF DEVICES ALLOWED.</u> The number of video gaming terminal devices permitted upon a licensed premises at any one time shall not exceed that number authorized in the license issued for said premises by the State of Illinois.
- 8-8-9 LOCATION OF VIDEO GAMING TERMINAL(S). In addition to any other condition or regulation contained in this Article or in St. Clair County's Code of Ordinances or in the laws of the State of Illinois, no video gaming terminal shall be located in any establishment or upon any premises that does not qualify as a Licensed Establishment, Licensed Fraternal Establishment, Licensed Veterans Establishment, or Licensed Truck Stop Establishment, and which is properly zoned pursuant to St. Clair County's Zoning Code; however, in no event shall any video gaming terminal be placed or located in or upon the premises of any of the following types of establishments or businesses: Convenience Stores, gas stations/filling stations, or grocery stores.
- 8-8-10 <u>REGULATION ON DISTURBING THE PEACE</u>. No licensee issued a license under this Article shall permit the operation of any video gaming terminal, or any Licensed Establishment, including Licensed Fraternal Establishment, Licensed Veterans Establishment, or Licensed Truck Stop Establishment, in any manner which will disturb the peace and quiet of persons outside, or beyond the premises on which the video gaming terminal(s) is being used. No immoral or indecent selection shall be present in any video gaming terminal.
- 8-8-11 <u>SUSPENSION OR REVOCATION OF LICENSE</u>. The St. Clair County Board Chairman may suspend or revoke any license issued under this Article upon due notice to the licensee of the time and place of a public hearing, and after a public hearing, if the Chairman determines that the licensee has failed or refused to comply with any provision in this Article, has failed or refused to comply with any provision in Chapter 21 (Liquor) of the St. Clair County Code of Ordinances, has failed or refused to comply with other law(s) applicable to the business of keeping or providing video gaming terminals, or has been convicted by a court of competent jurisdiction of a violation of any provision of this Article or the Illinois Video Gaming Act, 230 ILCS 40/1, et seq. Nothing in this section shall affect the automatic loss or suspension of license described in Section 8-8-3 of this Article.
- 8-8-12 NO OTHER GAMBLING PERMITTED. Nothing in this Article shall be construed to authorize, regulate, permit, or license any other gambling device or authorize any gambling in the County other than that which is permitted as provided in this Article VIII or by state or federal law.
- SECTION 2: SEVERABILITY OF PROVISIONS. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.
- SECTION 3: EFFECTIVE DATE. This Ordinance will take effect immediately upon its passage and approval as provided by law. However, the issuing of licenses and the collection of licensing fees as provided in Article VIII will take effect on January 1, 2018.

9-c-3 RECOMMENDATION LETTER FOR ST. CLAIR COUNTY LIFE AND AD&D INSURANCE WITH HAYS COMPANY.

As a part of AIG's overall strategic review of its business portfolio announced in early 2016, they decided to make the strategic decision to exit and sell their portfolio of businesses in Group Benefits. The impact is that our current Life and AD&D policies with AIG will transition to Symetra based on its focus on this market. According to AIG, by focusing on groups with 500+ employees, they have found that Symetra is able to deliver a proprietary, streamlined process for seamless implementation, highly personal account service, and a fully integrated approach to claims management. Symetra is highly rated, well-known, and respected providers of group life and disability benefits. Important to note that the transition from AIG to Symetra is due to AIG exiting this business segment by selling its business to Symetra. This is not something that Hays Companies had any influence or control of.

The current four classes of employees and their benefits in our current AIG policy will continue under the proposed Symetra policy. The current premium rates under the AIG policy will continue under the Symetra policy and remain in place to December 31, 2018.

As you may remember we identified the following three items as being in the current AIG policy and not in the proposed plan design from Symetra:

- Bereavement and Trauma Counseling Benefit up to \$150/session

 Day Care Benefit The least of: the actual cost of care for that Dependent Child(ren) charged by that Day Care Center for that year or \$3,000

 Permanent Total Disability Benefit: 1% of AD&D Principal Sum, monthly until benefit ceases

We approached Symetra to ask consideration to include these items in their proposal. I have been informed that Symetra cannot offer the Permanent Total Disability Benefit as it is not filed in the State of Illinois. We have followed up to see if they would be in position to file for this benefit for our plan. At this point I have not heard back for Symetra on this request.

As we discussed items 1 and 2 are very minor and in the event of a life insurance claim may or may be an issue.

Hays recommend that the County accept the Symetra proposal for the Life and AD&D coverage. to work with Symetra in the short term to try to have the Permanent Total Disability Benefit included as part of our plan. If that ultimately proves unsuccessful we can go to the marketplace and determine if another carrier is willing to offer this benefit as part of the County's Life and AD&D program. While we hope that these benefits can be restored, the life and AD&D market is quite large and we would expect a number of carriers to bid on the County's Life and AD&D program.

AGREEMENT between DISTRICT NO. 9, INTERNATIONAL ASSOCIATION OF MACHINISTS AND AEROSPACE WORKERS and ST. CLAIR COUNTY DEPARTMENT OF ROADS & BRIDGES

JANUARY 1, 2017 THROUGH DECEMBER 31, 2019

Preamble

This Agreement entered into by St. Clair County, Illinois, hereinafter referred to as "EMPLOYER" (or "DEPARTMENT"), and District 9 of the International Association of Machinists and Aerospace Workers, hereinafter referred to as "UNION", supersedes and cancels any and all previous agreements, whether written or verbal, between Employer and Union or any individual, and concludes all collective bargaining negotiations for the term of this Agreement, except as specifically provided herein.

Employer and Union mutually agree that the objective set forth herein is the entire agreement covering rates of pay and wages, hours of employment, and other conditions of employment; to promote the efficiency and productivity of employees in the St. Clair County Department of Roads and Bridges; and to provide for prompt and fair settlement of grievances without any work stoppages which interfere with the operation of the St. Clair County Department of Roads and Bridges. It is Employer's and Union's desire to provide the people of St. Clair County, Illinois, with the highest-quality service by mutual agreement through good-faith negotiations. agreement through good-faith negotiations.
