#### **New Business:**

Jim Jacquot informed the committee members of the events in May that the adoption center attended. First was the Air Force Ball, they had a silent auction for a pet adoption. The silent auction went for over two thousand dollars. The next event was the St. Clair County Heritage Foundation held downtown Belleville, which we had brought animals to. Also, Bob Trentman had his annual Anti Bullying event at High Mount School, we also had animals there. So we have been out just about every weekend.

Jim Jacquot told everyone that we are at the start of kitten season. We were closed down three days last week, because out facility was full, we could not take any more animals. This is probably going to be the case on and off, from now own.

Jim Jacquot went over the monthly statistics; the figures are pretty much staying the same. The live release rate of 61-62%. I don't know how long we can keep up with this, with all the animals we have been getting. We haven't as of yet had to euthanasia for space. But if it continues this way, I don't know how we can prevent that. But we are trying. We are so full due to the time of year; it is nice out, now our bite cases are up because the children are out of school.

Bob Trentman asked if we are getting any calls on cat ordinances or any feedback from anybody. Jim Jacquot replied no. I know that Dr. Lawler has arranged a meeting with Mayor Eckert, and the new mayor of O'Fallon to talk to them about that ordinance. To see if they can pass a municipal ordinance. I have a meeting tomorrow with Dr. Lee of SIU, who is trying to organize a way of counting the cats, through her doctorate program through her biology department. Now I don't know how that is going to go actually because they pulled a lot of funding at SIU Edwardsville and sent it to Carbondale. So she is not sure on how much money we'll have to do this, but I will find that out tomorrow. Steve Reeb asked Jim Jacquot how did you get involved with her. Jim replied, Dr. Lawler is with the Illinois State Museum, he is also a professor at SIU Edwardsville, and he has worked with Dr. Lee on other projects. There is also a Dr. Kohn at the biology department who is interested in maybe helping out with this. I don't know to what extent they are going to help or what their thinking is on the whole thing. They have done the counting of animals not cats particularly; Dr. Lee is called the urban scientist. She is more into rodent control, in large cities and she has done this all over the world. She just received a big award from National Geographic's. If she was interested she would be a great one to have around. If they need money from us, that may slow down the whole thing.

Bob Trentman asked if someone donated some dog bones. Jim Jacquot replied I forgot, the Animal Welfare Advocates on Friday brought a laundry basket full of Nyla bones to

Animal Control. The puppies love them, the older dogs just kind of look at them; the most of them have never had a toy of any kind. So they really don't know what to do with them.

## **Open Discussion:**

Jamie Case from Gateway Pet Guardian announced they are on the council agenda for East Saint Louis, for the cat ordinance for this month. Steve Reeb asked if they were meeting with the mayor. Jamie Case replied, she meets with the city attorney. Jim Jacquot replied Washington Park is allowing that now, unofficially. I don't know if they are going to jump on board officially, but the more cities that do it the better it will work.
