HERBERT SIMMONS READ HIS EMA REPORT OF ACTIVITIES TO THE COMMITTEE.

TOM KNAPP STATED THE JAIL POPULATION COUNT THIS AFTERNOON AT 2:00 WAS 399 THE DOC RATE IS 418, SO NOT TO BAD FOR MEMORIAL DAY WEEKEND. MAJOR KNAPP ALSO REPORTED DURNING THE MONTH OF APRIL WE ADMITTED 540 DETAINEES AVERAGE LENGTH OF STAY WAS 4 DAYS AND THAT INCLUDED 130 FEMALES, 410 MALES. 222 CHARGED WITH MISDEMEANOR AND 159 WERE CHARGED WITH FELONIES. PATROL ACTIVITY FOR THE MONTH OF APRIL WE INITIATED 327 TRAFFIC STOPS, 202 CITATIONS WHERE ISSUED AND 9 FELLONY ARREST, 32 MISDEMEANORS ARREST, AND 44 WARRANT ARREST.

THERE WHERE 302 COURT HOUSE CHECKS, 646 PARK PATROL AND A TOTAL OF 7452 POINTS OF CONTACT WITH THE PUBLIC. THE ENVIORNMENTAL OFFICER HAD 124 POINTS OF CONTACT WHICH WAS WAY UP. ISSUED 12 ENVIORNMENTAL CITATIONS AND THE REST OF THE DEPARTMENT HAD 14 CONTACTS WITH ZERO CITATIONS.
