4. **DEMOLITION PROGRAM**:

Mr. Mitchell reported on the Spivey Building that a structural engineer from Oates reported that he could do a walk-through of the Spivey Building for \$4,000.00 to \$5,000.00 to look and see what kind of structural deficiencies exist and whether or not it is worth saving. It was suggested that we contact an architect more so than a structural engineer. Mr. Mitchell stated that he called SCI regarding the asbestos and was told they could do the asbestos survey. They said they would collect 300 samples for \$8,250.00. Mr. Mitchell advised that they think the engineering company that owned the building before they lost it had already done the asbestos survey. Mr. Mitchell advised he has tried to contact the previous owner to find out what has already been done and to date has not received a call back. Discussion ensued with comments from Mr. Mosley, Jr..

Mr. Mitchell further reported that Washington Park is completed and Market and South 16th Street are finished. Mr. Mitchell presented the following invoices for approval for payment: S. Shafer Excavating Inc. in the amount of \$59,800.00 for Washington Park and S. Shafer Excavating in the amount of \$9,000.00 for Market and S. 16th Street; MS Mitch Consulting in the amount of \$10,200.00 for Washington Park and \$850.00 for Market and S. 16th Street. A motion was made by Mr. Mosley, Jr., seconded by Mrs. McIntosh, to approve the invoices from S. Shafer Excavating, Inc. and MS Mitch Consulting for payment. Motion carried.

Mr. Mitchell further advised that on the East St. Louis Project 5, Hayes has already started and on Monday already had four (4) houses down. The one at 1641 Cleveland, the guy said he was in jail for the last three years and his brother was supposed to be making the payments. Mr. Mitchell said he called Mr. Strohmeyer about the issue and advised the party he needed to come to Edwardsville and pay. Mr. Strohmeyer stated that the gentleman did call the office inquiring about an amount.

Mr. Mitchell advised on East St. Louis Project 6 he is missing a photo of 800 St. Clair Avenue property and he will email it or bring it in next time.

Mr. Mitchell advised he had nothing further to report.
