IT WAS MOVED BY STEVE GOMRIC AND SECONDED BY ROY MOSLEY, JR. TO APPROVE THE DECEMBER 17, 2018 MINUTES. MOTION CARRIED.

FRANK BERGMAN READ THE DETENTIONS POPULATION REPORT FOR NOVMBER 20TH THRU DECEMBER 12, 2018. THERE BEING NO QUESTIONS, IT WAS MOVED BY STEVE GOMRIC AND SECONDED BY PAUL SEIBERT TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND THE REPORTS. MOTION CARRIED.

HERBERT SIMMONS READ HIS NOVEMBER 2018\DECEMBER 2018, E.M.A. REPORT TO THE COMMITTEE.

THERE WHERE NO QUESTIONS, IT WAS MOVED BY STEVEN GOMRIC AND SECONDED BY KEVIN DAWSON TO ACCEPT THE EMA REPORT AND PLACE IT ON FILE. MOTION CARRIED.

TOM KNAPP REPORTED THAT OUR DOC RATE OF CAPACITY FOR THE MONTH OF NOVEMBER WAS 418. OUR AVERAGE DAILY POPULATION DURING NOVEMBER 2018 WAS 353 THAT IS DOWN FROM LAST MONTH. INMATES ADMITTED 596, AVERAGE LENGTH OF STAY WAS FOUR DAYS, OLDEST PERSON WAS 67 YRS OF AGE; OF THE 596 INMATES 141 WERE FEMALES AND 455 WERE MALES. BOOKING TYPES, 212 MISDEMEANORS, 206 FELONS, 7 FEDERAL INMATES, AND 85 FUGITIVES AND A HAND FULL OF OTHERS.

ON THE PATROL SIDE OF THINGS FOR NOVEMBER 2018, WE MADE 330 TRAFFIC STOPS, ISSUED 216 CITATIONS, 19 FELONY ARRESTS, 30 MISDEMEANOR ARRESTS, 42 WARRANT

ARRESTS, 346 COURTHOUSE CHECKS, 637 PARK PATROLS AND 3,012 BUSINESS/RESIDENTS CHECKS.

FOR A TOTAL POINTS OF CONTACT FOR NOVEMBER 2018 WAS 7,818 WITH THE GENERAL PUBLIC. THE ENVIRONMENTAL OFFICER HAD 88 CONTACTS MADE, 12 ENVIRONMENTAL CITATIONS ISSUED, 10 VIOLATION NOTICES LEFT AT RESIDENTS. AND THE ACCIDENT REVIEW BOARD MEET. 8 ACCIDENTS OVERALL; 4 CHARGEABLE, 4 NON-CHARGEABLE. JUST IN CASE NO ONE KNOWS WE HAD ONE OF OUR K9, CASO PASSED AWAY (HAD TO BE PUT DOWN). TOTAL DEPARTMENT K9S DOWN TO 2 FROM 4.

THERE BEING NO QUESTIONS, IT WAS MOVED BY STEVE GOMRIC AND SECONDED BY PAUL SEIBERT TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.
