ROLL CALL FOR THE MARCH 26, 2018 PUBLIC SAFETY MEETING.

THERE WERE NO COMMENTS FROM THE PUBLIC REGARDING THE MEETINGS AGENDA.

IT WAS MOVED BY ROY MOSLEY, JR. AND SECONDED BY PAUL SEIBERT TO APPROVE THE JANUARY 29, 2018 MINUTES. MOTION CARRIED.

JOHN HUGHES READ ALL THE CORRESPONDENCE FOR THE MONTH. IT WAS MOVED BY KEVIN DAWSON AND SECONDED BY MICHAEL O'DONNELL TO ACCEPT AND PLACE ON FILE ALL CORRESPONDENCE AND REPORTS. MOTION CARRIED.

HERBERT SIMMONS PRESENTED HIS EMA REPORT OF ACTIVITIES FOR THE MONTH OF JANUARY/FEBRUARY 2018. THERE BEING NO QUESTIONS, IT WAS MOVED BY PAUL SEIBERT AND SECONDED BY KEVIN DAWSON TO ACCEPT THE EMA REPORT AND PLACE IT ON FILE. MOTION CARRIED.

TOM KNAPP REPORTED THE FOR THE MONTH OF JANUARY THE POPULATION WAS 356 WHICH IS DOWN. OUR LOWEST DAY WAS ON THE LAST DAY OF JANUARY WITH 342. FOR THE RECORD IN JANUYARY WE ADMITTED 569 PEOPLE; AVERAGE LENGTH OF STAY 4 DAYS, OLDEST PERSON 79 YEARS OLD. SENTENCED TO JAIL 43, THERE WERE 127 FEMALES ADMITTED, AND 482 MALES. BOOKING TYPES 190 MISDEMEANORS, 176 FEDERALS AND 90 FUGITIVES.

ON THE PATROL SIDE OF THINGS FOR JANUARY 305 TRAFFIC STOPS ISSUED, 192 CITATIONS, 7 FELONY ARREST, 21 MISDEMEANORS, 25 WARRANT ARREST.

WE DID 298 COURT HOUSE CHECKS, 637 PARK PARTORLS, AND 2341 BUSINESS/RESIDENTIAL CHECKS; FOR A TOTAL OF 6846 POINTS OF CONTACT WITH THE GENERAL PUBLIC.

THE ENVOIRNMENTAL OFFICER HAD 88 CONTACT MAKE; ISSUED 7 ENVIORNMENTAL CITATIONS AND 14 VIOLATION NOTICES.

LAST WEEK THE SHERIFF, MYSELF AND OTHERS MET WITH THE ST. CLAIR COUNTY TRANSIT DISTRICT. THE SHERIFF WAS INVITED TO SUBMIT A PROPOSAL TO GET MORE DEPUTIES ON THE METROLINK; 3 FOR NOW. THE TRANSIT DISTRICT WAS IN AGREEMENT TO FUND IT. IN PRINCIPLE, DEPUTIES WOULD RIDE IN ILLINOIS INTO MISSOURI FOR A HAND FULL OF STOPS OUT TO THE DELMAR LOOP. ST. LOUIS CITY, THE MAYOR, POLICE CHIEF AND METRO ARE IN FAVOR OF IT. SO WE ARE WORKING THROUGH THE LOGISTIC RIGHT NOW AND HOPEFULL THIS IS IN THE NOT TO DISTANT FUTURE TO BE PART OF THE PROGRAM.

JERRY DINGES ASKED IF THESE ARE ADDITONAL PEOPLE.

TOM KNAPP STATED YES.

MARK KERN STATE ADDITIONAL FROM WHAT WE ARE PASSING TONIGHT.

FRED BOCH ASKED IF THEY WOULD BE ASSIGNED TO THE METROLINK CARS; CAN THEY GO ANYWHERE.

TOM KNAPP STATED THEY ARE DEPUTIES ASSIGNED TO METROLINK AND WE HAVEN'T MET ANY OBSTACLES YET WHICH IS GOOD NEWS.

MARK KERN STATED THE DUTIES WOULD BE METROLINK TRANSIT AND PLATFORM. THERE BEING NO QUESTIONS, IT WAS MOVED BY ROY MOSLEY, JR., SECONDED BY PAUL SEIBERT.

JOHN HUGHES READ THE ACCIDENTS REPORT FOR THE MONTH.

STEVE GOMRIC ASKED IF THE SHERIFF DEPARMENT WOULD REVIEW OUR SCHOOL SHOOTING POLICY AND MAKE SURE IT IS UP TODATE WITH WHAT IS GOING ON IN FLORIDA RIGHT NOW.

TOM KNAPP STATED SOME OF THE STAFF AND I AM GOING ON A RETREAT TOMORROW AND I'M SURE IT WILL BE A TOPIC OF DISCUSSION. THERE BEING NO QUESTIONS, IT WAS MOVED BY MICHEAL O'DONNELL AND SECONDED BY PAUL SEIBERT TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.
