#### **New Business:**

James Jacquot replied he has met with a lot of the rescues this month concerning, mainly heart worm positive animals, we are still in the process of that, but I think we will come up with a collaborative effort, I don't think we will resolve it but it will help a lot. We meet with SIU Edwardsville, they are starting their counting of the cats in Belleville. Dr. Lee was at the Belleville Humane Society with some of the rescues and spoke about what they wanted to do. They have a student that is going to be heading it, she meet with us there, she is pretty bright, she is going to be graduating in May, so she is trying to get a lot of this done before she graduates. All and all I think the meetings were pretty productive.

Robert Trentman replied so we started up a small committee with a couple.

James Jacquot replied with a group of six and that was one of the meetings we had, and the main topic on the agenda was the heartworms, we are trying to address that right now.

Robert Trentman replied so the committee is?

James Jacquot replied it is Belleville Area Humane Society, Gateway Pet Guardians, Stray Angels, St. Clair County Advocates, and TNR Rescue and us.

Robert Trentman asked about the dog food bowls.

James Jacquot replied yes, it's taken care of.

Robert Trentman replied we have new bowls for the big dogs. Ashley how are the adoptions going.

Ashley Jett replied doing good. We have full kennels and full quarantine, doing really well.

Robert Trentman asked how are the cats, do we have a lot of cats up for adoption or not really.

Ashley Jett replied we barley have any cats in the whole building.

Robert Trentman replied, so my wife, someone dumped a cat at our farm, a little black cat and I have never had an inside cat. We took it and had it spayed at All About Pets, it was really easy and my wife took care of it. We dropped it off and picked it up and it was really nice. It lays around the house a lot and wrestles with the dog, we have a puppy inside. We have the spay/neuter event coming up on the 21<sup>st</sup>, do we have people signing up.

James Jacquot replied we are starting pre-registration on the second of April.

Steve Gomric replied is there a cap?

James Jacquot replied no.

Jamie Case, Gateway Pet Guardian asked how many do you usually do?

James Jacquot replied between three and four hundred. This is our largest one, normally the second one we decide how much money we have left and how many we can do on the second one and the first one is open to everybody, and we do as many as we can.

Robert Trentman replied give a flyer to each one of the rescues, so you guys got it, so you can let anyone know that we are having this coming up. Who passed this paper out, one of the recuses. So Jamie from Gateway passed this out, it shows the number of animals that different rescues are taking.

Jamie Case, Gateway Pet Guardian replied it is the impact of all the rescues, all of the other organizations besides AC are doing to impact the number of animals coming in, the things that we are doing to either reduce the number of intakes or increase the number of live outcomes.

Robert Trentman replied by the look of these numbers it is really, everybody is doing their part.

Fred Boch replied I just wonder if anyone would like to speak up because they didn't have time.

Robert Trentman replied we had open discussion.

Jamie Case, Gateway Pet Guardian replied I know that Best Friends is going around and they are trying to create these coalitions in every county in the state, and that is there goal. I am pretty confident that the group that we formed with all of the organizations I think St. Clair County is the first one in the state of Illinois to be formed officially.
