The low bid was submitted by Right Way Traffic Control of \$28,359.99.

Upon a motion by Mr. O'Donnell and seconded by Mr. Seibert, it was unanimously agreed to approve the (St. Clair County) Resolution surplusinga 1999 Ford Explorer VN 1FMZU34E2XUC31452 and a Rhino FR120 Mower Deck Serial No. 10066 / Sec. 18-00000-02-EQ.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Resolution awarding contract for the replacement of the existing three span structure carrying Reinneck Road (TR 194) over Hazel Creek in the Freeburg Road District to Depew and Owen Builders, Inc. at the low bid of \$333,258.00 / Section 16-08106-02-BR.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Resolution allowing Caseyville Twp. Sewer Department, by Highway Permit 2666, to install a sanitary sewer force main along and under C.H. 16, Maintenance Section R 17-1, Hartman Lane.

Upon a motion by Mr. Gomric and seconded by Mr. Seibert, it was unanimously agreed to approve the Resolution allowing Verizon / MCI Metro Access Transmission Services Corp., by Highway Permit 2668, to install a fiber optic along and under C.H. 46, Maintenance Section P 66-1, Frank Scott Parkway West.

Upon a motion by Mr. Gomric and seconded by Mr. Seibert, it was unanimously agreed to approve the Resolution allowing Verizon / MCI Metro Access Transmission Services Corp., by Highway Permit 2669, to install a fiber optic along and under C.H. 58, Maintenance Section H 54-1, Old Caseyville Road.
