- (B) Resolution surplusing 1999 Ford Explorer VIN 1FMZU34E2XUC31452 and Rhino FR120 Mower Deck Serial No. 10066/ Sec. 18-00000-02-EQ. Motion made by Mr. Crawford, seconded by Mr. Allen to approve. All members present voted aye.
- (C) Resolution awarding contract for the replacement of the existing three span structure carrying Reinneck Road (TR 194) over Hazel Creek in Freeburg Road District to Depew and Owen Builders, Inc. at the low bid of \$333,258.00 / Section 16-08106-02-BR. Other Pertinent Business:

Norm Etling presented the Annual Report for NPDES Permit for Storm Water Discharges from Separate Storm Sewer Systems. He reported it was posted on the County Web Site and open to any public comments. He explained the basis of the program as well as the six basic requirements.

A question was raised about the IEPA requirement and the testing. Mr. Etling explained it was part of an agreement with the IEPA and the Co-Permittee Group. Components include physical water sampling and reports, distribution of flyers and inlet stenciling.
