Mr. Simmons reported that 32 agencies purchased 498 portable radios from Motorola during a bulk purchase period. These agencies saved 55% off the regular purchase price due to the agreement he negotiated. There was a total savings of \$976,063.26.

Mr. Simmons also reported that the radio purchase was in addition to the 750 pagers that were presented to area first responders at no cost to the county or the agencies.

A motion was made by Mr. Trentman and seconded by Mr. Bingel to approve the EMA Report. Motion passed unanimously.

Michael Gilbert, SCSESA, gave a presentation on behalf of the EMS side of Special Emergency Services. Mr. Gilbert spoke about how they assist EMS/Law Enforcement/Fire at scenes. They provide cooling/heating services as well as set up at special events to assist EMS. They also help reduce overcrowding in area hospital emergency rooms.
