Chairman Vernier called the meeting to order with the Pledge of Allegiance at 5:30 PM

Chairman Vernier asked for a Moment of Silence for past committee member Carol Clark.

Mr. Crawford made a motion seconded by Mr. O'Donnell to approve the minutes of scheduled meeting held February 11, 2019. All members in attendance voted aye.

The Chairman Vernier asked if there were any comments on the Agenda. None were presented.

Chairman Vernier asked if there were any comments from the audience. Mrs. Hildebrandt addressed the Committee about a traffic signal at Scott Troy and Borchers Lane.
