## MINUTES:

A motion was made and seconded to approve the minutes of the November 20, 2019 Trustee Committee Meeting. Motion carried.

## 2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. <u>Revolving Account Activity</u>: The Revolving Account Activity Report for November 2019 shows a Beginning Balance of \$9,865.97, Total Disbursements of -\$0-, Receipts of \$13,507.01, Allocated Pool Interest in the amount of \$11.94 with a Balance at Month End of \$23,384.92`.

S. Shafer has finished the demolition of 22 structures for project1902- ESL. S. Shafer Excavating submitted an invoice for \$157,100.00.

A motion was made by Mr. Mosley, Jr., seconded by Mr. Greenwald to pay the invoice from S. Shafer in the amount of \$157,100.00. Motion carried.

MS Mitch Consulting submitted an invoice for demolition coordination of 22 structures, newspaper publications and asbestos surveys in the amount of \$17,600.00.

A motion was made by Mr. Mosley, Jr., seconded by Mr. Greenwald to pay the invoice from S. Shafer in the amount of \$17,600.00. Motion carried.

Mr. Mitchell stated that S. Shafer is starting the Washington Park 20 demolitions tomorrow. He is also putting another 33 structures out for bid for January 22. The structures are located on 21<sup>st</sup> through 28<sup>th</sup> and 76<sup>th</sup> Street to 87<sup>th</sup> Street.

Mr. Mosley, Jr. made a motion, seconded by Mr. Pruett to approve the purchase of four (4) cameras to monitor the clean-up site. Motion carried.
