A bid opening was held this evening for Garrison School. There were five bidders – Supreme Trucking \$134,724.00; S. Shafer Excavating, \$127,000.00; Hank's Excavating \$102,000.00; Hayes Contracting, \$105,722.00 and Hayden Wrecking was \$234,321.00.

Mr. Mitchell recommended the low bidder, Hank's Excavating with a bid of \$102,000.00.

A motion was made by R. Mosley, Jr., seconded by D. Pruett to accept the bid and approve the Demolition Coordinator's report. Motion carried.

R. Mosley, Jr. told the committee that 1010 Sycamore was on the demolition list but he knows of a buyer who would like to rehab the property. Mr. Mitchell will remove it from the demolition list and Mr. Strohmeyer will put the property in the April auction.
