AND SECONDED BY MICHAEL O'DONNELL TO ACCEPT AND PLACE ON FILE ALL
CORRESPONDENCE AND THE REPORTS. MOTION CARRIED.**

**HERBERT SIMMONS READ HIS DECEMBER 2018 JANUARY 2019, E.M.A. REPORT TO THE
COMMITTEE.**

**THERE WERE NO QUESTIONS, IT WAS MOVED BY STEVEN GOMRIC AND SECONDED BY
KEVIN DAWSON TO ACCEPT THE EMA REPORT AND PLACE IT ON FILE. MOTION CARRIED.**

**TOM KNAPP REPORTED THAT FOR THE MONTHS OF DECEMBER 2018 WE ARE AVERAGING
THE YEAR ON THE JAIL SIDE OF THINGS 602 INMATES ADMITTED, AVERAGE LENGTH OF
STAY WAS 4 DAYS, OLDEST PERSON 74 YRS OF AGE. OF THE 602 INMATES 148 WERE FEMALES
AND 454 MALES, 231 WERE MISDEMEANORS, 206 FELONS, 3 FEDERAL INMATES, AND 96
FUGITIVES AND A HAND FULL OF OTHERS.**

**FOR THE MONTH OF DECEMBER THE AVERAGE DAILY POPULATION WAS 348 AND 418 AS OUR
DOC RATE OF CAPACITY WHICH IS SUFFICIENTLY UNDER. FOR THE YEAR 2018 THE JAIL
FROM JANUARY THRU DECEMBER 2018, INMATES ADMITTED 7752 SLIGHTLY DOWN FROM**

2017.. AVERAGE LENGTH OF STAY 11 DAYS, OLDEST PERSON ADMITTED 80 YRS OLD. FEMALES 1861, MALES 5891, OF THE 7752, 2719 WERE MISDEMEANORS, 2511 FELONS, 88 FEDERAL AND 1203 FUGITIVES. FOR THE YEAR THE AVERAGE DAILY 2018 POPULATIONS WAS 342 WHICH IS SLIGHTLY DOWN.

ON THE PATROL SIDE OF THINGS FOR 2018, WE MADE 256 TRAFFIC STOPS, ISSUED 132 CITATIONS, 24 FELONY ARRESTS, 34 MISDEMEANOR ARRESTS, 46 WARRANT ARRESTS, 337 COURTHOUSE CHECKS, 572 PARK PATROLS AND 2,710 BUSINESS/RESIDENTS CHECKS. FOR THE MONTHS 7,360 TOTAL POINTS OF CONTACT WITH THE GENERAL PUBLIC.

THE ENVIRONMENTAL OFFICER HAD 70 CONTACTS MADE, 4 ENVIRONMENTAL CITATIONS ISSUED, 8 VIOLATION NOTICES LEFT AT RESIDENTS.

FOR THE YEAR OF 2018 WE HAD 4,321 TRAFFIC STOPS, 2,522 CITATIONS, 278 FELONY ARRESTS, 394 MISDEMEANOR ARREST, 462 WARRANT ARRESTS, 4,078 COURTHOUSE CHECKS, 7,019 PARK PATROLS, 37,009 BUSINESS/RESIDENCE CHECKS AND FOR A TOTAL OF 97,586 POINTS OF CONTACT WITH THE GENERAL PUBLIC.

I'M SURE EVERYONE KNOWS WE HAD AN OFFICER DEPUTY INVOLVED SHOOTING FRIDAY, AND IT IS STILL UNDER INVESTIGATION. I WILL BE TURNING IN A REPORT TO THE STATE'S ATTORNEY OFFICE IN THE NEXT FEW DAYS. I CAN'T COMMENT ON IT. I'LL BE HAPPY TO GIVE A MORE DETAILED REPORT NEXT MONTH. THERE BEING NO QUESTIONS, IT WAS MOVED BY STEVE GOMRIC AND SECONDED BY PAUL SEIBERT TO ACCEPT HIS REPORT AND PLACE IT ON FILE. MOTION CARRIED.

FRANK BERGMAN STATED ON THAT THERE IS NOT MUCH ON THIS MONTH'S ACCIDENT REPORT. IF YOU HAVE ANY QUESTIONS I'LL BE HAPPY TO ANSWER THEM. THERE BEING NO QUESTIONS, IT WAS MOVED BY STEVE GOMRIC AND SECONDED BY PAUL SEIBERT TO ACCEPT THE ACCIDENT REPORT AND PLACE ON FILE.
