TRUSTEE COMMITTEE MEETING – JANUARY 23, 2019

1. MINUTES:

A motion was made and seconded to approve the minutes of the December 12, 2018 Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

- a. Revolving Account Activity: The Revolving Account Activity Report for December 2018 shows a Beginning Balance of \$59,827.56, Total Disbursements of \$16,930.00, Receipts of \$7,195.81, Allocated Pool Interest in the amount of \$55.78 with a Balance at Month End of \$50,149.15.
- b. <u>Payment Account Activity</u>: The Payment Account Activity Report for December 2018 shows a Beginning Balance of \$1,289,738.40and a Balance at Month End of \$1,267,329.93.

c. Monthly Redemption Reports:

The Real Estate Monthly Redemption Report for December 2018 shows the Amount of Penalty as \$82,618.25; the Amount of Tax as \$202,035.46; Year to Date Totals of the Amount of Penalty as \$455,363.93 and the Year to Date Amount of Tax as \$1,275,609.33. - Chaunce Gillespie: Mr.Gillespie requested a reinstatement with time payments on account #201200261. The property is located at 1607 Wilford Avenue in East St. Louis. The account is delinquent in the amount of \$5,524.14. The property is in the auction. Any extension would require full County Board approval. A motion was made by Mr. Mosley, Jr., seconded by Mr. Crawford to accept a down payment in the amount of \$800.00 and a balance of \$279.00 to be paid by January 24, 2019, remove from the auction and approve a six (6) month time payment extension with full County Board approval. Motion carried.
- s. <u>Lawanda Carraway by Whitney Strohmeyer</u>: Ms. Carraway requested an extension on account #0717197. The property is located at 1137 North 44th Street in Washington Park. The account is delinquent for taxes in the amount of \$8,003.81. She sent a personal check in the amount of \$1,000 to Mr. Strohmeyer's office. The amount needed was \$1,599.00. No action.

4. **DEMOLITION PROGRAM**:

Mr. Mitchell presented a bill from Hank's Excavating for 18-01-PSL in the amount of \$115,500.00. The project is now finished and it looks good.

Mr. Mitchell presented a bill from S. Shafer Excavating for the Clark Middle School for the remainder due in the amount of \$62,000.00.

Also, he presented an invoice from CT Services to do the asbestos survey at 4100 Trendley which is the Garrison School for \$3,200.00.

A motion was made by R. Mosley, Jr., seconded by Ms. McIntosh to pay the invoices. Motion carried.

Mr. Mitchell stated that ESL-4 project was awarded to Hanks Excavating and he should be starting the end of this week. He has been reminded of the time frame and the fine for being late.

5. OTHER BUSINESS:

Mr. Cockrell, County Board Member, addressed the committee concerning Sinn's Inn in unincorporated Darmstadt. It has long been in disrepair and there was a fire on November 5 which destroyed the structure. It is on three parcels, two of which the Trustee owns, and the parcel in the middle is due to become Trustee property the end of April. The fire was extinguished by the St. Libory Fire Department with the help of other local departments. The Village of St. Libory has sent an \$800 invoice to the Fire Department for water used to extinguish the fire. The Fire District asked if the Trustee would pay the bill. Mr. Cockrell questioned whether there is any precedence for paying water bills for firefighting. Mr. Strohmeyer explained that the Trustee never owns the property and it is placed in a trust for the taxing districts and Illinois statute protects the Trustee and the taxing districts when they acquire property from delinquent taxes from any and all liability. The Trustee will not pay the bill. Mr. Cockrell is going to notify the Fire District that the bill is between them and the Village.

Mr. Cockrell also stated that Anne Markezich, Director of St. Clair County Zoning, has had an offer to clean up the property in exchange for possession of the property. Mr. Strohmeyer stated that it is very unusual to sell to an individual outside of the auction. It doesn't normally happen. He mentioned that the Trustee does sell to municipalities and local governments at a minimal amount to cover costs. Also, noted was that the County at this time has no money in the budget for demolition.

6. **ADJOURNMENT**:

A motion was made and seconded to adjourn at 8:35p.m. Motion carried.
