# 1. MINUTES:

# 4. **DEMOLITION PROGRAM**:

Mr. Mitchell stated there was a bid opening was this evening at 6 p.m. for 20 houses in Washington Park and two (2) in East St. Louis. There were two (2) bidders Shafer Excavating -\$157,000 and Hanks Excavating for \$171,250. Mr. Mitchell recommended taking the low bid from Shafer Excavating.

A motion was made by R. Mosley, Jr., seconded by S. Greenwald to award the bid to Shafer Excavating. Motion carried.

Mr. Mitchell also presented a retention agreement for Mr. Mitchell to handle the demolition program which will be due in August.

A motion was made by R. Mosley, Jr., seconded by M. Crawford to renew the agreement between the demolition coordinator and the County Board Trustee Committee with the approved changes. Motion carried.

Mr. Mitchell reported that East St. Louis demolition permits were \$130 per structure last year and they are now charging \$260. R. Mosley, Jr. called East St. Louis City Hall and asked them to honor last year's price as the committee was unaware of the change. All future demolition will be at the higher rate.

# 5. **OTHER BUSINESS**:

Mr. Strohmeyer received a request from Mayor Rickie Thomas, Washington Park, to purchase some lots and some of the houses that have been offered at auction with no bids. Some of the requested properties are newer and they are in the next auction for the first time. One is a house the rest are vacant lots. The Committee agreed to allow the purchase of the properties by Washington Park contingent upon the previous owners not making a payment.

### 6. **ADJOURNMENT**:

A motion was made and seconded to adjourn at 8.40 p.m. Motion carried.
