Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Ordinance Approving the issuance by the Southwestern Illinois Flood Prevention District Council of not to exceed \$105,000,000 Flood Prevention District Council Sales and Tax Revenue Bonds, Series 2020, of the Council for the purposes of performing emergency levee repair and flood prevention and refunding certain outstanding bonds; the execution and delivery of an amendment to the existing intergovernmental agreement among the County, the St. Clair County Flood Prevention District and said Council related thereto; the authorization of the continued intercept of all revenues from the County's flood prevention

retailers' occupation tax and flood prevention service occupation tax, in connection with said issuance of bonds; and related matters.

Upon a motion by Mr. Gomric and seconded by Mr. Seibert, it was unanimously agreed to approve the Resolution Agreeing to participate in the service program of the Office of the State's Attorneys Appellate Prosecutor for the Fiscal Year 2020 by hereby appropriating \$42,000 as a portion of the funds required for financing the office of the State's Attorneys Appellate Prosecutor, and agreeing to deliver the same to the Office of the State's Attorneys Appellate Prosecutor on request during FY 2020.

Upon a motion by Mr. Tieman and seconded by Mr. Gomric, it was unanimously agreed to approve the Transportation Resolution to Enter into Separate Contracts with Lochmueller Group and Philip Johnson Realtor to Provide Negotiation and Relocation Service on Projects Overseen by St. Clair County.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Transportation Resolution Renaming a Portion of Curtiss-Steinberg Road from its Intersection With Vector Drive to a Point Approximately 500 Feet Northeasterly of that Point to Sauget Industrial Parkway.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Transportation Resolution Granting Everstream GLC Holding Company, LLC Authority to Install a Communications Cable Under Summerfield Road South, County Highway 50, Approximately 405 Feet South of Illinois Route 161.

Upon a motion by Mr. Easterley and seconded by Mr. Tieman, it was unanimously agreed to approve the Transportation Ordinance Reducing the Posted Speed Limit Along North Green Mount Road from Frank Scott Parkway East, County Highway 95, South to Lebanon Avenue to 40 Miles Per Hour.

Upon a motion by Mr. Tieman and seconded by Mr. Gomric, it was unanimously agreed to adjourn the meeting at 6:50 p.m.
