MINUTES:

A motion was made and seconded to approve the minutes of the August 21, 2019 Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

4. **DEMOLITION PROGRAM**:

Mr. Mitchell stated that 19-01–WP which included 21 properties is complete. S. Shafer was previously paid for eight (8) properties and he submitted an invoice for the remaining structures for \$92,800.00.

He also submitted an invoice from S. Shafer for three (3) properties in East St. Louis for \$25,765.00

A motion was made by Mr. Mosley, Jr., seconded by Mr. Greenwald to pay the invoices presented. Motion carried.

Mr. Mitchell submitted his invoice for the 21 properties in Washington Park which included newspaper publications and asbestos surveys was \$15,750.00 and for the three (3) properties in East St. Louis for \$2,2050.00.

A motion was made by Mr. Mosley, Jr., seconded by Mr. Pruett to pay the invoices presented. Motion carried.

Mr. Mitchell reported that Ameren was complaining about the amount of brush around the houses but they have agreed that is their responsibility.

Mr. Mitchell said that they are working on the next group of houses in East St. Louis and it is primarily in the area of Gety and St. Louis Avenue.

Motion was made to accept the Demolition Coordinator's report. Motion carried.

5. **OTHER BUSINESS**:

Mr. Strohmeyer presented the list of Centreville properties in which Mr. King is interested in purchasing in Centreville. The properties were previously in the auction and received no bids. The Committee agreed to the sale.

In response to last month's discussion concerning changing the minimum bid Mr. Strohmeyer explained that changing the minimum bid would be confusing for most people. He explained that he thought the bigger problem is when the properties are being bought as an investment and a time extension is given and it goes to the next tax year and so they don't end up paying taxes for that year. He will research the problem further.

Mr. Mosley, Jr. expressed concern about people outbidding another buyer at the auction and then they don't have the 20% down payment. Discussion was held to make separate lines according to the purchase price in order to expedite the procedure. It was decided to have a separate line for purchases of \$15,000 or more in case the purchaser does not have the required funds. If they don't, the property could then be auctioned again that evening.

6. **ADJOURNMENT**:

A motion was made and seconded to adjourn at 8:40 p.m. Motion carried.
