Animal Control Reports:

Cheri: We have empty dog kennels, we have empty cat cages. The save rate for January was 99%. We had 13 adoptions in January. We also sent 98 animals to rescue. We're getting everything lined up for the spay and neuter clinic. Once we get everything ready to go we'll put it up on the web page, Ashley will post it on the adoption center facebook and we'll have flyers on the counter for people to take. There's not a set date. In the past it's been open to everybody. This time we're going to be taking the people on social security/disability and people on food stamps. So they'll have to come in and do the pre-registration, show us that they are receiving that and we'll go ahead and get all the paperwork and send it to the vet and they'll give them a surgery date.

Mr. Trentman: Anything going on in the adoption center as far as adoptions?

Cheri: There were 13 in January, kind of a low month, but actually at 4:40pm there was a dog adopted today that was already fixed and ready to go so that dog went home today.

Julie: We haven't had any cat adoptions in a while, we've been holding over cats (for illness) so that's partly why the numbers are a bit lower.

Mr. Trentman: I know a lady that has a semi-feral cat. She will come up to her, she said she can catch it and I think I'm going to give it to Nicole Webster to fix it.

Mr. Trentman: I just want to say again, last year the county was at 95% save rate. That is really awesome.

Mr. Mosley: I have a question. Is anyone else going to the ribbon cutting/grand opening for Gateway Pet Guardians shelter in East St. Louis going on tomorrow?

Mr. Trentman: I knew it was going on but I didn't know when.

Mr. Mosley: It's tomorrow at 5pm.

Mr. Trentman: They had a soft opening a couple of months ago, but this is the big one. Thanks for bringing it up.

Mr. Mosley: Did you know about it?

Cheri: I wasn't sure on the date.

Mr. Trentman: As you all know, Jamie Case's organization bought the school. I've been down there several times helping them out here and there. It's pretty impressive what they've done down there. I know they're taking a lot of animals from East St. Louis area and I think they have quite a few already down there. They took 11 in the other day, they had it on facebook. That's a big help to us, so we appreciate them.
