## **Public Comments:**

**Approval of Minutes:** Kevin Elbe asked for approval of the minutes for the December 10, 2019 meeting. A motion was made by Ken Easterley and seconded by George Chance to approve the minutes. The motion passed unanimously.

**Attorney Report:** Attorney Kevin Kaufhold reported that he is monitoring pending litigation filed by Madison County regarding 9-1-1 consolidation. No action needs to be taken by the ETSB Board at this time.

# **Director's Report:**

**Items For Information:** 

**Monthly/Annual Call Statistics:** Director Simmons referred to the monthly and annual call statistics for the ETSB Board to review.

**PSAP Consolidation Update:** Director Simmons informed the ETSB Board that staff attended the January 6 and January 13, 2020 meetings of the Statewide 9-1-1 Advisory Board to discuss changes to the current Emergency Telephone Systems Act. ISP staff has until January 24, 2020 to file updated legislation with the Illinois Legislature to ensure a bill is created for the spring session. The final language will be modified prior to the vote. The current Emergency Telephone Systems Act expires December 31, 2020. Madison County has filed suit against the ISP and Statewide 9-1-1 Administrator regarding the denial of their submitted consolidation plan.

**Resignation of ETSB Board Member:** Director Simmons referred to a resignation letter received by ETSB Board Member Chief Steven Brown due to an increase in responsibilities in his community. We thank him for his time and dedication to the ETSB Board.

Director Simmons updated the ETSB Board on addressing totals for 2019. A total of 422 new addresses were issued for the year. As of October 2019, the ETSB started charging a \$25 administrative fee per new address issued for a total of \$2,675.00 collected to help cover rising costs and staffing required to issue addresses.

### **Items for Action:**

**Priority Dispatch Contract Renewal:** Director Simmons requested the ETSB Board's approval in renewing the contractual agreement with Priority Dispatch for the annual usage and liability protection involving the Emergency Medical Dispatch systems. The amount of \$28,800.00 is identical to previous year's pricing.

Kevin Elbe asked for a motion to approve the contract renewal with Priority Dispatch. A motion was made by George Chance and seconded by Randy Bolle to approve the Priority Dispatch contract in the amount of \$28,800.00. The motion passed unanimously.
