MINUTES:

A motion was made and seconded to approve the minutes of the December 11, 2019 Trustee Committee Meeting. Motion carried.

2. TAX AGENT'S REPORTS AND RESOLUTIONS:

4. **DEMOLITION PROGRAM**:

- Mr. Mitchell presented the 20-01-ESL bid opening that was held this evening. Three (3) companies bid; Hanks Excavating \$282,470.00; Middendorf \$379,700.00 and S. Shafer Excavating \$268,260.00. S. Shafer was the low bidder.
- S. Shafer Excavating submitted an invoice for 19-02-WP for 21 demolitions in the amount of \$115,700.00 and an invoice in the amount of \$30,000.00 for 2 demolition in East St. Louis.

MS Mitch Consulting submitted an invoice for demolition coordination of 21 structures, newspaper publications and asbestos surveys in the amount of \$16,800.00.

A motion was made by Mr. Mosley, Jr., seconded by S. Greenwald to approve the invoices for payment. Motion carried.

Mr. Mitchell also submitted an invoice for demolition of 3205 State Street in East St. Louis for \$800.00, two cameras for \$366,45 and clearing 3 lots at 915 Trendley for a total of \$1,466,45.

A motion was made by Mr. Mosley, Jr., seconded by Mr. Pruett to approve the invoice for payment. Motion carried.

5. **OTHER BUSINESS**:

Mr. Mosley, Jr. stated that he is going to meet with the City of East St. Louis to discuss the control of grass and weeds overgrowth on properties in conjunction with the City. He will report next month.

Mr. Strohmeyer discussed the property at 806 34th Street. It consists of four lots. The house was being paid on and it is in the default process and it is going to be demolished. The lots are in the auction for next week. He questioned if the committee wanted to sell the lots separately or remove the lots from the auction and after the house is demolished it can be sold as a bundle. The Committee agreed to remove lots and sell as a bundle.

Bishop Phillips, Power of Change Church, contacted Mr. Strohmeyer questioning the status of the house at 1917 Central. The City of East St. Louis has agreed to purchase and convey to the Church. The Committee agreed to sell the property for the standard minimum.

Mr. Strohmeyer explained that Chris Rodgers purchased a house in the auction and the lot next to it was included. The Village of Washington Park had expressed interest in the lot. Mr. Strohmeyer would like the Committee's permission to do a swap of properties with Mr. Rodgers. The Committee was in agreement.

Mr. Strohmeyer presented a list of requests for the purchase of lots from the Village of Washington Park. Three (3) of the properties are in the auction. Mr. Strohmeyer asked the Committee if he should pull those properties. The Committee directed him to remove them from the auction.

Mr. Strohmeyer requested guidance on the Bank Building that Soul Searching is requesting to demolish.

A motion was made by Mr. Mosley, Jr., seconded by Mr. Greenwald that the County Trustee handle the demolition and then sell it to the interested party for the price of the demolition. Motion carried.

6. **ADJOURNMENT**:

A motion was made and seconded to adjourn at 8:05 p.m. Motion carried.
