Sue Schmidt discussed the bond refinancing globally.

Upon a motion by Mr. Tieman and seconded by Mr. Gomric, it was unanimously agreed to approve the Resolution Authorizing and Providing for the Issuance of not to Exceed \$29,000,000 Taxable Highway Revenue Refunding Bonds, of The County of St. Clair, Illinois, for the purpose of paying the costs of refunding certain outstanding highway revenue bonds of the County, and authorizing the sale of said bonds to the purchaser thereof.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Ordinance Authorizing and Providing for the Issuance of not to Exceed \$57,000,000 Taxable General Obligation Refunding Bonds (Alternate Revenue Source) of the County of St. Clair, Illinois, Providing for the Payment of Certain Outstanding Alternate Bonds of said County, Providing for the Levy of a Direct Annual Tax Sufficient to Pay the Principal and Interest Thereon, and Authorizing the Sale of Said Bonds to the Purchaser Thereof.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Ordinance Authorizing and Providing for the Issuance of not to Exceed \$3,000,000 Taxable General Obligation Debt Certificates (Limited Tax) of St. Clair County, for the Purpose of Refunding Certain Outstanding Debt Certificates of the County Issued to Provide Improvements to the County's 911 System, and Authorizing the Sale of Said Certificates to the Purchaser Thereof.

Upon a motion by Mr. Gomric and seconded by Mr. Tieman, it was unanimously agreed to approve the Ordinance Authorizing and Providing for the Issuance of not to Exceed \$3,250,000 Taxable General Obligation Debt Certificates (Limited Tax) of St. Clair County, for the Purpose of Refunding Certain Outstanding Debt Certificates of the County Issued to Provide Construction of a Storage Facility at MidAmerica St. Louis Airport, and Authorizing the Sale of Said Certificates to the Purchaser Thereof.
