## Resolutions:

- (B) Resolution authorizing execution of a Preliminary Engineering Services Agreement with Thouvenot, Wade & Moerchen Inc. for the preparation of the plans, special provisions and cost estimate for the proposed addition of a southbound right turn lane from Old Collinsville Road on to Ashland Avenue, County Highway 96. Mr. Crawford made a motion seconded by Mr. Allen to approve. All members in attendance voted aye
- (C) Resolution authorizing execution of an agreement between St. Clair County, City of O'Fallon and Aberdeen Village, LLC., for the addition of northbound right turn lanes, signals, striping and incidentals along Scott-Troy Road, County Highway 61. Section 18-00253-16-PW. Development is easterly of Scott-Troy and northerly of IL Route 50. Mrs. Chartrand made a motion to approve seconded by Mr. Crawford. All members present voted aye.
